Most Humbly, I Smt Renu Mahato, Wife of Rajeshwar Prasad Mahato, Resident of Santoshi Nagar, Near Maa Santoshi Mandir, Ward no-5 of SMC, P.O & P.S-Siliguri, Dist-Darjeeling do here write this complaint before you against persons namely Persons namely 1. Rambabu Mahato son of Gagan Sardar 2. Smt Usha Devi Mahato, Wife of Rambabu Mahato 3. Kartick Mahato Son of Rambabu Mahato 4. Ganesh Mahato Son of Rambabu Mahato 5. Rukmani Mahato 6. Raja Mahato 7. Nisha Mahato all are resident of Santoshi Nagar, near shitla mandir ward no-5 of SMC, Under Siliguri Police Station & 8. Pappu Mahato and Ranjan Sahani both area resident of Hemanta basu Colony, WARD NO-4 of SMC, Under Siliguri Police Station, stating that in the year 2025 Rambabu Mahato took money from me and by good faith I gave him money and passing some month when I go to his house for take my money back he refused it and passing day and day on dated-03/03/2026 I again go to his house situated at ward no-5 and from outside his home I told him to return back my money but he again refuse it and with the intention of revenge they all persons gathered near my house around on the same day dated-03/03/2026 around 9:00 PM at Night they all gathered near my house and started saying slang languages when my daughter Sangita Mahato came out to saw them why they abusing me then suddenly they all started beaten my daughter and one of the person Ranjan Sahani attack my daughter with a iron rod and Pappu Mahato attacked my daughter with a sharp knife a various cut she have on her body when my daughter started shouted loudly in bleeding situation then I along with my elder daughter swati mahato ran away to save her then they all started beaten us badly with iron rod, wooden stick and sharp knife some persons wear iron punch in their hands a hitted upon my face as well as my daughter faces they tort my daughter clothes and saying" that tumlogo ko nanga karenge" Ranjan Singh and his associated touched my daughter's body having bad intention and they all started destroyed my house started break my house main Door they broke my window glass and entered in my house and started looted my property, they assaulted my another married daughter also as well as his children who are 6 yrs another is 1 yrs, due to hitted by punch we all have grivious injury upon head, back and chest , my daughter's have cut upon her body and our head were swelling blood on that time and a saviour injury I have upon my left eye due to this I have problem to saw ,when local people call police then they ran away if the police didi not come then they kill us that time in the scared situation we all go to the Siliguri district hospital for treatment due to councillor's advice we could not lodged any

police complaint against all the persons but they all are came day by day near my house and threatened my daughter's and me when

my daughter's passed from the road side then started eve-teasing and today dated-09/03/2026 the persons namely Ranjan Sahani and Pappu Mahato near my house around 6:00 Pm stopped my daughter and touched her breast having bad intention but when my daughter started shouted loudly then threatened that they raped her.

Now my daughter's are very scared and I came before you to inform that they can do any unnecessary crime with my daughter's because many times they came go alone, they threatened that they kill my husband and son also. Due to councillor and political persons advice me for mutual and compromise I could not make any complaint before you ddue to this the delay complaint has been lodged before you against incidents.

I am requesting before you to kindly accept my complaint as F.I.R and take strict action against all the persons who committed this offences.
