Sub:- FIR Against Manish Kumar Prasad, S/o Upendra Kumar Prasad, resident of Gossainpur, Notun Para, P.O. Gossainpur, P.O. Bagdogra, Dist. Darjeeling.

I, Nibedita Roy, Daughter of Dhaniram Roy, resident of Gossainpur, Notun Para, P.O. Gossainpur, P.O. Bagdogra, District Darjeeling, West Bengal, do hereby most respectfully submit as follows:

1. That one namely Manish Kumar Prasad came into contact with me during the year 2021 while both of us were preparing for the WBCS Examination. He approached me under the pretext of providing study materials and academic assistance and gradually developed a close association with me.
2. That on the basis of trust and good faith I accepted his friendship. Subsequently he expressed romantic interest and over time we entered into a relationship. At the initial stage I was unaware of his malicious and dishonest intentions.
3. That on one occasion under the pretext of introducing me to his mother he invited me to his residence. Relying upon his representation and acting in good faith I visited his house. Upon reaching there and I found that his mother was not present. He falsely represented that she had gone nearby and would return shortly.
4. That during my stay at his residence he offered me a soft drink. After consuming the same and I began to feel physically uncomfortable and soon lost consciousness. And I was not in a position to understand or resist what was happening.
5. That upon regaining consciousness I found myself lying on a bed in a distressed condition experiencing severe pain in my private parts and other parts of my body. From the circumstances and I realized that the he had committed sexual intercourse with me without my consent while I was unconscious.

6. That when I confronted he regarding his act and he attempted to pacify me and assured me that he would marry me. Being emotionally shattered and considering my social reputation and family honour and I felt compelled to rely upon his assurance.
7. That thereafter he repeatedly established physical relations with me under the false promise of marriage. He continued to assure me that marriage would take place shortly.
8. That during the first incident and subsequent occasions he clandestinely took certain photographs without my knowledge and consent.
9. That thereafter he used those photographs to threaten and blackmail and compelling me to continue the physical relationship under fear of social defamation.
10. That while I was pursuing my post-graduation at Darjeeling Hill University, Mongpoo, the said Manish Kumar Prasad frequently visited me and by way of intimidation and emotional coercion forced me to accompany him and submit to his physical demands.
11. That on 23.12.2025 he compelled me to accompany him to Mirik and made arrangements to stay in a homestay. Despite my objections he ignored my resistance. He further took me to a temple at Mirik and forcibly applied sindoor on my forehead and falsely creating an impression of marriage and further misleading me.
12. That recently upon missing my menstrual cycle and apprehending pregnancy and I informed Manish Kumar Prasad. He took me to a doctor and administered medicines. When I requested him to solemnize or legally register the marriage and he categorically refused and stated that he would not marry me and challenged me to take any action.
13. That I state that the accused intentionally deceived me from the inception and administered an intoxicating substance to facilitate sexual assault, repeatedly exploited me sexually under false promise of marriage and subjected me to continuous blackmail intimidation and mental harassment.

Sir I therefore requesting you to take legal action against the accused person as per law.
