Sir,

I, ASI Dipak Karmakar of Bhaktinagar P.S. Siliguri Police Commissionerate, do hereby lodged this written complaint against the arrested accused persons namely; (1) Biswajit Darnal @ Khupia (28 yrs) S/O Late Manoj Darnal of Prakash Nagar, near Swimming Pool, Ward No.42, PS- Bhaktinagar, Dist- Jalpaiguri (2) Bibek Bhujel (26 yrs) S/O Late Pradip Bhujel of Jinglan, Near Jinglan High Secondary School,, PS- Rangli, Dist- Darjeeling (3) Alok Roy (35 yrs) S/O Late Nirendra Nath Roy of Santipara, Salugara, Ward No. 42, PS- Bhaktinagar, Dist- Jalpaiguri (4) Suroj Chettri @ Yogesh @ Malli (32 yrs) S/O Late Kumar Chettri of Malli, Near Chalisay Bazar, PS- Malli, Dist- South Sikkim and (5) Palash Mandal (28 yrs) S/O Late Pujan Mandal of Shantinaga, Near Sporting Club, Ward No.37, PS- Bhaktinagar, Dist- Jalpaiguri under arrest along with following seizure articles (i) One iron made knife with wooden handle measuring approx 12 inches , recovered from the possession of Biswajit Darnal @ Khupia (which was on his hand ) (ii) One Iron made Sickle with wooden handle measuring approx 9.5 Inches , recovered from the possession of Bibek Bhujel ( it was on his hand) iii) One Iron mada screw driver measuring approx 12 Inches, recovered from the possession of Alok Roy (iv) One iron made Hammer measuring approx 14.5 inches recovered from the possession of Suroj Chhetri @ Malli (it was on his hand) and (v) one iron made two way range measuring approx 07 inches recovered from the possession of Palash Mandal (it was on his hand). In this regard, I beg to report that on 10.03.26 at 00.35 hrs received secret reliable source information that about 11/12 anti socials being armed with deadly weapons assembled at Hydarpara Market Complex, ward no. 40 under Bhaktinagar PS for making preparation to commit dacoity in a house at Hydarpara area under Bhaktinagar PS. I informed this source information to I/C Bhaktinagar PS and noted the information vide Bhaktinagar PS GDE No. 481 Dated 10.03.26. As per the direction of I/C Bhaktinagar PS, at 00.45 hrs, I along with ASI Khagen Barman, SI Youel Lepcha, SI Pintu Ghosh, C/953 Himangshu Barman, C/828 Dulal Chandra Barman along with investigation Kids left for Hydearpara Market Complex, ward no. 40 under Bhaktinagar PS for working out the information vide Bhaktinagar GDE No. 482 Dated 10.03.26 after briefing officers and force properly. At 01.10 around hrs we reached at Hydarpara Market Complex, ward no. 40 under Bhaktinagar PS and kept our vehicle at considerable distance Hydarpara Market Complex, ward no. 40 under Bhaktinagar PS. By this time as informed by secret source, we could see a group of persons standing and were whispering in subdued suspicious manner. On seeing us, they tried to flee away but somehow, above noted five persons could be apprehended and detained them. Then, after disclosing our identity, I asked them their motive to assemble at such a place and in such odd hours of night and in such a suspicious manner. On being asked they disclosed their names and address ás noted above and admitted that they along with 06/07 others assembled at the spot for making preparation to commit dacoity tonight in a house at Hydarpara area under Bhaktinagar PS. I accordingly searched them in presence of witnesses and found (i) One iron made knife with wooden handle measuring approx 12 inches , recovered from the possession of Biswajit Darnal @ Khupia (which was on his hand) (ii) One Iron made Sickle with wooden handle measuring approx 9.5 Inches , recovered from the possession of Bibek Bhujel (it was on his hand) iii) One Iron mada

screw driver measuring approx 12 inches, recovered from the possession of Alok Roy (iv) One iron made Hammer measuring approx 14.5 inches recovered from the possession of Suroj Chhetri @ Malli (it was on his hand) and (v) one iron made two way range measuring approx 07 inches recovered from the possession of Palash Mandal (it was on his hand) were making preparation for committing Dacoity tonight in a house at Hydarpara area but others managed to escape from the spot. Accordingly, I seized above noted weapons in presence of witnesses under proper seizure list duly signed by them and arrested them, informing them their ground of arrest preparing memo of arrest. The seizure was made in between 01.20 hrs to 01.55 hrs. The whole search, seizure were made under proper Videography as per norms. On further interrogation the arrested accused persons confessed that they along with others assembled at the spot for making preparation to commit Dacoity tonight in a house at Hydarpara area, but others managed to escape from the spot.

From the above noted facts, seizure and circumstance there is reason to believe that accused persons had assembled there with deadly weapons for making preparation to commit dacoity in a house at Hydarpara area under Bhaktingar PS.

Therefore, I pray before you to start a specific case against the above noted arrested accused persons and others 06/07 others who fled away, under proper section of law and to cause its investigation.
