Respected Sir,

With due respect myself Kanchan Gupta (Ram), S/O- Lt. Srikishan Ram is a permanent resident of ((Vill+PO- Tulshi Hata, PS- Harishchandra Pur, Dist.- Malda, West Bengal, 732140), and presently residing in a rented house styled as GUPTA APARTMENT (Bhanu Nagar, PS- Bhakti Nagar, Dist.- Jalpaiguri). I would like to inform you that I am the **Managing Director** of **OXFORD GROUP OF INSTITUTIONS** located at Tea Auction Road, Mallaguri, PS- Pradhan Nagar, Dist. Darjeeling. On 8th March 2026 at around 8 pm I received a telephonic information from the Security Guard of our College Premises namely Vivekananda Saha, that one incident of theft occurred at our college. After receiving such information I went to the College and found out that **7 (Seven) numbers** of following **Corporate Cell Phones including Sim** were stolen from my Office Chamber and also found that **Rs. 50,000 (Fifty Thousand) cash** has been also stolen from the Almirah of the concerned Staff Room.
