In producing herewith 03(Three) arrested accused persons namely 1.Krishna Swarnakar (50 Yrs) S/O Lt. Baidhyanath Swarnakar of Dakshin Mahendrapur, Islampur, PO-Mahendrapur, PS-Harishchandrapur, Dist-Malda 2.Kausar SK (26 Yrs) S/O Rekab SK of Jaykrishnapur, Chandnidaha, Nimtila Joykrishnapur, PO-Joykrishnapur, PS-Dhulian, Dist-Murshidabad and 3. Morsalim SK (38 yrs) S/O Jalauddin SK of of Jaykrishnapur, Chandnidaha, Nimtila Joykrishnapur, PO-Joykrishnapur, PS-Dhulian, Dist-Murshidabad (not verified) along with the following articles under seizure as per seizure list:

- One packet containing 3.630 Kg of Ganja wrapped with brown colour cello tape inside a Blue Coloured bag styled as "ACTION BAG" and Marked as " Exhibit-A".
- One packet containing 3.645 Kg of Ganja wrapped with brown colour cello tape inside a Black and pink Coloured bag styled as "SKY BAGS" and Marked as " Exhibit-B".
- One packet containing 3.650 Kg of Ganja wrapped with brown colour cello tape inside a Navy Blue and pink Coloured bag styled as "SKY BAGS" and Marked as " Exhibit-C".
- One packet containing 3.140 Kg of Ganja wrapped with brown colour cello tape inside a Maroon and white Coloured bag styled as "FASHION" and Marked as " Exhibit-D".

I, SI Ganesh Roy of Detective Department, Siliguri Police Commissionerate do hereby lodge this written complaint against above noted persons to the effect that on 09/03/2026 at about 21.05 hrs I received a specific source input that 03 (three) persons have stored huge quantity of Ganja at their rented room at Baghajatin Colony, Ward No-03, PS-Pradhan Nagar, Dist-Darjeeling for delivering the same to their designated customers. The matter was diarized in DD, SPC, GDE No.60, Dt- 09.03.2026 and also informing the matter to the ACP, DD, SPC in written and being directed, I along with SI Krishna Parja, C/686 Arup Saha, LC/1332 Jayanti Oraon, CV/150 Bikash Kumar Thakur all belongs to DD, SPC left for Baghajatin Colony, by Govt. vehicle to verify the veracity of the information vide DD, SPC PS M.C. C. NO 76/26 Dt. 09/03/2026.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

At the time of departure from DD, SPC, office I took envelope, white paper, sealing wax, gum, seal, Digital weighing machine (Certified by the weight and Metallurgy department) etc.

On way to Baghajatin Colony, I contacted two persons namely (i) Md. Aftab (36 Yrs) S/O Md. Chhote of South Baghajatin Colony, Ward No-03, PS- Pradhan Nagar, Dist-Darjeeling (8942842604), (ii) Nasruddin (37 yrs) S/O Shaikh Ansar of Bhandar, Ward No-03, PS-Dhaka, Dist-Motihari, Bihar (8597907715) and make them aware of the information in hand and requested them to act as witness, if any search and seizure would be made necessary upon which they agreed. Thereafter we along with the independent witnesses reached at the rented room located at Baghajatin Colony, Ward No-03, PS-Pradhan Nagar, Dist-Darjeeling, at 21.35 hrs and subsequently being pointed and shown by my reliable source I apprehended the above noted persons.

Thereafter, we disclosed our identity and the information in hand and stated them that they will be searched in person for the purpose. At this, they after disclosing their identity as noted above, they admitted that they have illegally procured and stored Ganja in their rented room for selling the same to their designated customers as per requirement in high price for their wrongful gain. Then I gave them option in writing whether they wanted to be searched in presence of an Executive Magistrate or by any Gazetted Officer. Then they agreed to be searched in presence of any one of the above. I also offered the
