Subject: First Information Report (FIR) for physical assault on my family

Sir/Madam,

I, Shri Bidhan Chandra Sarkar son of Late Bamesh Chandra Sarkar, residing at CPWD Quarter, Hakimpara, Siliguri, Darjeeling, PIN - 734001, wish to lodge this complaint against Shri Bishwajit Majumdar son of Late Birendra Chandra Majumdar, and his wife, his son (residents of the same quarter complex) for a violent physical attack on me, my wife and my son. The accused person's wife is making false and fabricated allegations against my son and my family to harass, defame, and mentally intimidate us.

The dispute arose due to the persistent and deliberate unhygienic activities of the accused family, specifically the **throwing of garbage in front of my garage** and the **frequent urinating of their dog in front of our main gate, my door & surrounding areas**. Despite our repeated requests and specifically telling them not to do these things, the accused family became aggressive.

On the night of 21st February, the accused family—Shri Bishwajit Majumdar, his wife, and his son—launched a sudden and violent attack :

- 1. Attack on my son (Bikram Sarkar):** The accused person Bishwajit Majumdar struck my son on the head with a heavy flower pot, causing a **severe head injury (left side) with active bleeding**. Furthermore, Bishwajit Majumdar, his wife, and his son collectively attacked on Bikram sarkar, causing multiple **nail scratches and bruises on his neck, chest, and right hand**.
- 2. Assault on my wife (Basanti Sarkar) Daughter (Mita Sarkar):** From past few months Shri Bishwajit Majumdar was eve-teasing my wife Basanti Sarkar and During the incident, **Shri Bishwajit Majumdar and his wife, his son directly attacked and physically-verbally assaulted my wife Basanti Sarkar and my daughter Mita Sarkar**. My wife was physically intercepted and manhandled. My wife, Basanti Sarkar, sustained visible **nail scratches on her neck and face** as a result of this physical assault.
- 3. Ongoing Threats & Intimidation:** Furthermore, I wish to bring to your urgent attention that the accused parties are now calling outsider individuals to our residential area. The outsider is coming to our gate and attempting to threaten and intimidate us, creating an atmosphere of fear and insecurity for my family, especially for the women members.

My son immediately contacted the emergency services and the incident was recorded under ID 293907. The accused family fled the scene as the police arrived. Following the advice of the attending officers, my son has undergone medical examination for his injuries at the hospital. I request you to register this as a formal **First Information Report (FIR)** I request you immediate legal action.
