Respected Sir / Madam,

I, Dr. Somu Pradham, residing at Salugana, opposite SBI bank, dist Jalpaiguri (Pin code - 734008), wish to file a formal complaint regarding a road accident that occurred on 3rd March, 2026 at approximately 5:45 pm around at check post area nearby Lifeline hospital.

I was riding my scooter WB 74 AC 8788 (Honda Activa), when a car with plate number BK 01 P 7206 model Bolero Grey colour driven by Sanjay Raut gave me a pass sign, so I overlooked the car thinking he gave me a sign but he hit me from the side (right side) where I was overtaking the car. The accident was caused by rash & negligent driving of the car driver, which resulted in my hand, back, chest, head, thighs & leg injuries (chip off from the little toe finger) and drastic damage to my scooter. Immediately following the accident, the driver admitted his fault. To prevent me from initiating legal actions the traffic police was also present there & ask me if I

would like to file a complaint or the driver will bear all my expenditure, on which I went for the second option.

So, the driver promised to bear all costs for medical treatment and vehicle repairs. Relying on this verbal assurance & their apparent good faith I didn't file an immediate FIR.

It is now evident that the driver made a false promise with the intent to deceive me & escape legal consequences at the time of accident.

The reason of filing this complaint late is due to my injuries as I couldn't walk properly.

I request you to register an FIR against this.

I look forward to your swift action on this matter.
