In producing here with the seized articles viz:-

- 1) Total 04 (four) Numbers of Hindustan petroleum Domestic Empty Gas Cylinder Net. Weight 14.2 Kgs.
- 2) Total 01(One) Number of Bharat Petroleum Domestic full loaded gas Cylinder Net Weight 29.2 Kgs. Approx

Under proper seizure list. I SI Raju Sarkar of Enforcement Branch, Siliguri Police Commissionerate do hereby lodge a written complaint against Dimik Lepcha (58 yrs) S/O Lt. Palchen Lepcha of Patel Road No 03, W/No 2 PS- Pradhanagar , Dist- Darjeeling owner of "Dimik Momo Restaurant Shop" located at Patel Road No 03, W/No 2 PS- Pradhanagar , Dist- Darjeeling who was illegally procured the domestic Gas cylinder at his Momo shop styled as "Dimik Momo Restaurant Shop" for commercial purpose without any valid documents or license to the effect that today i.e. 10.03.26 at about 11:30 hrs vide Enforcement Branch SPC, GDE No. 51 Dt. 10.03.26 in course of Joint Inspection with Food & Safety Department and Other Officials (A team formed vide Memo No 87/SMC/G Dt.13.05.2025 of Siliguri Municipal Corporation) arrived at above noted Restaurant styled as "Dimik Momo Restaurant Shop" situated at above mentioned address and found using the domestic Gas cylinder at his Restaurant for preparing food items for using commercial purpose for his wrongful gain.

Hence I informed the matter to ACP EB, SPC and as per his instruction I along with officers and force conducted raid in the restaurant run by Dimik Lepcha (58yrs) S/O Lt. Palchen Lepcha of Patel Road No 03, W/No 2 PS- Pradhanagar , Dist- Darjeeling. During search found worker of Restaurant making food items by using the domestic HP and Bharat Petroleum gas cylinder without any valid documents for commercial purpose, On demand they failed to produce any valid documents in support of using the HP and Bharat Petroleum gas cylinder in Restaurant styled as "Dimik Momo Restaurant Shop" for commercial purpose.

It is crystal clear that the said person namely Dimik Lepcha (58yrs) S/O Lt. Palchen Lepcha of Patel Road No 03, W/No 2 PS- Pradhanagar , Dist- Darjeeling is using the Domestic gas cylinders in his Restaurant for his wrongful gain. As per local enquiry it came to light that the above noted person storing and using gas negligently with respect to fire or combustible matter, which may endanger human life or likely to cause hurt or injury to person at that locality area. Dimik Lepcha does not have any valid Documents regarding above seized articles . Thus the above noted accused person violated the provision of West Bengal Cooking Gas (License and Control) order 1985 and other Government Orders.

Accordingly I seized the above noted seized articles as per seizure list in presence of I witnesses namely 1) Chitta Barman (26) S/O Lt Anil Barman of Champasari Anchal and 2) Koushik Mondal S/O Ram Chandra Mondal of Matigara Government Colony PS- Matigara, Dist- Darjeeling . The seizure was made in between 13:10 hrs to 13:40 hrs.

Hence, I pray that a specific case may be recorded against the accused person namely Dimik Lepcha (58 yrs) S/O Lt. Palchen Lepcha of Patel Road No 03, W/No 2 PS- Pradhanagar , Dist- Darjeeling U/S 287/3(5) BNS R/W Sec 7(1)(a)(b)(c) of EC Act 1955 and other appropriate sections of law.
