I, Sri Tapas Bishui, Divisional Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Rajiv Kashiramka, (Ph No-9748283451), S/o- Lt. Shyam Sundar Kashiramka, Ground Floor, Vyom Heights, Himachal Sarani, Hyderpara, Ward-40, Siliguri, Dist-Jalpaiguri- 734006 for having committed offence as stated here under.

On 11.03.2026 at about 01:25 p.m. acting on a source information I, along with 1) Sri Bhaben Roy, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (2) Sri Biswajit Ghosh, Linesman, Hakimpara CCC and other officials of WBSEDCL entered the residential building of Rajiv Kashiramka and inspected service installation, metering installation of Consumer ID **402837935** in the name of Rajiv Kashiramka. During inspection it was found that electricity was being used from existing domestic connection unauthorisedly & illegally for commercial purpose.

As unauthorised commercial uses from domestic service connection were detected the energy meter make Larsen & Toubro, serial no.- **RBRT13587** installed against Con Id. **402837935** seized by preparing a formal seizure list duly signed by Rajiv Kashiramka and witnesses. The copy of the seizure list handed over to Rajiv Kashiramka and his signature obtained as token of receipt.

As Rajiv Kashiramka have committed offence u/s 135(1)(e) of Electricity Act 2003 by using electricity illegally & unauthorisedly for commercial purpose from domestic connection, you are requested to take cognizance of the same by treating this complaint as FIR.
