Subject: *Written Complaint*

Respected Sir,

I, Sri Ravi Basfore, aged about 40 years, S/o Kailash Basfore, permanent resident of B.R.I. Colony, Pradhan Nagar, Ward No. 1, under Siliguri Municipal Corporation, District – Darjeeling, West Bengal, Pin – 734003, do hereby most respectfully submit this written complaint for your kind and immediate action under law:

1. That on 11.03.2026 at about 9:00 PM (night), a serious incident occurred near my residence. On that night, Ajay Basfore (brother of the complainant Ravi Basfore) requested Sanshkar Basfore not to smoke and use abusive language near my house, as the female members of my family were present and felt uncomfortable. During this time, a minor altercation took place between me and Sanshkar Basfore, which was subsequently pacified by the local people present there.
2. That prior to the said incident, I had requested the accused persons to settle the matter peacefully in the presence of local people, but the accused persons refused to do so and threatened me by saying “maar ka badla maar hoga”, thereby clearly indicating their intention to cause grievous harm and even to kill me.

3. That thereafter the accused persons namely (1) Sajan Basfore, (2) Subh Basfore, (3) Sanshkar Basfore, (4) Harsh Basfore, (5) Harish Basfore, (6) Ranjan Basfore and (7) Sangharsh Basfore, along with three female persons (names not known to me), became aggressive and started quarrelling with me. On 12.03.2026 at about 12:30 P.M. (Day), all the accused persons, in furtherance of their common intention, jointly assaulted me and attacked me with bala (Kara/ Kadha) and wooden sticks, causing serious injuries on my head and other parts of my body.
4. That the accused persons attacked me in such a violent manner with the intention to cause my death, and their acts clearly amount to **attempt to murder**.
5. That due to the severe assault by the accused persons, I sustained grievous injuries on my head and other parts of my body and was immediately taken to the **District Hospital**, where I am presently undergoing medical treatment.
6. That the acts committed by the accused persons constitute offences punishable under the relevant provisions of law including **attempt to murder, grievous hurt, unlawful assembly, rioting and criminal intimidation**.
7. Therefore, I humbly request you to kindly **register an FIR and take strict legal action** against the above-mentioned accused persons under the appropriate provisions of law for **attempt to murder, grievous hurt, unlawful assembly, rioting and criminal intimidation**.

8. That I am also annexing herewith the photographs of my injuries and the medical report issued by the **District Hospital** in support of this complaint.

Hence, I most humbly request you, sir, to kindly register a case against the following accused persons: (1) Sajan Basfore, (2) Subh Basfore, (3) Sanshkar Basfore, (4) Harsh Basfore, (5) Harish Basfore, (6) Ranjan Basfore and (7) Sangharsh Basfore, along with three female persons (names not known to me) for committing offences punishable under appropriate provisions of law, and to take necessary legal action in the interest of justice.
