1. That on 04-03-2026, during the celebration of Holi festival when I, along with my family members namely Dharti Bala Barman (my wife), Jyotsna Barman (my mother), Mohim Barman (my Father), Sandip Barman (my younger brother) were together enjoying the festivities at the porch of our house.

2. That the following persons who are my also my neighbours namely: (1) Satish Roy S/O Late Binod Roy, (2) Manik Roy S/O Late Binod Roy (3) Kabita Roy W/O Manik Roy, (4) Parul Roy W/O of Late Binod Roy and (5) Reena Singha Roy, W/O Satish Roy all are residents of Sonamalijote, Kestopur, P.S: Bagdogra, District: Darjeeling were also playing holi in the locality.

That (1) Satish Roy S/O Late Binod Roy, (2) Manik Roy S/O Late Binod Roy in an intoxicated state started to tease my wife named Dharti Bala Barman and they also teased my mother named Jyotsna Barman by using filthy language and vulgar gestures. Since they were in an intoxicated state and of desperate nature we ignored them to maintain peace and tranquility within the locality. It is pertinent to mention to here that when me and my wife were alone in porch area and were cleaning the place **Satish Roy** and **Manik Roy** taking advantage together trespassed the porch of my house and they touched and tried to disrobe my wife and upon seeing this when my wife raised hue and cry and I protested against their they started assaulting me. This action of mine infuriated them and they grabbed me by my collar and hair and took me to their house where (1) Satish Roy (2) Manik Roy (3) Kabita Roy and (4) Parul Roy and (5) Reena Singha Roy together started assaulting me and upon seeing this when my wife raised hue and cry for help my family members along with my wife came to my rescue but unfortunately my wife and I was beaten up mercilessly and resultantly we sustained severe and fatal injured. Moreover (1) Satish Roy (2) Manik Roy (3) Kabita Roy and (4) Parul Roy and (5) Reena Singha Roy threatened that they will
