Then I thought to ask them about  
their relation, I went to them and asked them specially  
my wife Pratna Laha, who is this man and what is  
your relation? suddenly that man hit me in my forehead  
I was shocked, at the same time he, that man hit me  
again in my forehead with a bottle in attempt to kill me  
suddenly there appeared other 2 men and one female and  
also started punching me and scratched me in my back,  
where I got fainted and I remember my friends somehow

It is pertinent to mention here that my wife is separated and now staying at 'Sakya Kunj', Salbari, near 'The Furniture Furrigone house' and also she had same behaviour before. I would also like to mention here that even staying separately <sup>and case is pending before Siliguri</sup> I took over her and my daughter in all terms (monetary and also take my daughter for cutting, - exams, support in whatever ways). My wife along with her boyfriend and his friends attacked me without any rhyme and reason that too with a glass bottle in my head, which could cause a death.

I therefore request the concerned authority to take immediate legal action for me same for against my wife Pratina Lama and her boyfriend and other three persons for ends of justice.
