Subject: Complaint for Registration of FIR regarding Attempt to Murder, Robbery, Assault, Outraging Modesty and Criminal Intimidation


Respected Sir,

I, Tanmay Roy, son of Jiten Chandra Roy, by profession a practising Advocate at Siliguri Court and presently residing at Sukanta Pally, Shib Shakti Kali Bari Road, Siliguri, most respectfully submit this complaint seeking immediate registration of an FIR against Manoj Ghosh and Manob Ghosh of Dhaneshwari Kali Mandir area, Ranjit More of Ashighar, Siliguri, along with about 16 other unidentified associates, who were acting in concert as members of a notorious group locally known as the "KGF Gang" of Siliguri."

On 04.03.2026 at about 7:30 PM, I along with my friend Jay Nayyar, son of Smt. Bimala Nayyar, and a few other friends had lawfully entered Montana Vista Club, Uttorayon City Centre, Matigara, Siliguri, with valid entry passes for attending a private social gathering. While we were peacefully present there, the above-named accused persons along with around 16-20 associates suddenly assembled inside the club in an intoxicated and aggressive condition and began creating disturbance. They started passing filthy and obscene remarks towards our female friend **Ankita Paul, daughter of Shri Shyamal Paul of Ashighar, Siliguri**, and wrongfully restrained and attempted to drag and manhandle her, thereby clearly attempting to outrage her modesty.

When I intervened to protect her, the accused persons under the leadership of Manoj Ghosh and Manob Ghosh surrounded me and my friend Jay Nayyar and launched a brutal assault upon us. They mercilessly punched, kicked and struck us, pushing us to the ground and repeatedly attacking us on vital parts of the body including the head and chest, while some members restrained us and others continued the assault. The attack was so violent that I nearly lost consciousness and feared for my life, clearly indicating that the accused persons acted with knowledge and intention that their acts could cause death, thereby amounting to an attempt to murder. During the said assault, while we were being overpowered, one of the accused forcibly snatched the gold chain weighing about 14 grams from the neck of my friend Jay Nayyar, having an approximate market value of about Rs. 2,00,000/-, and another removed cash amounting to about Rs. 11,000/- from my pocket, thereby committing robbery by use of criminal force. After committing the offence, the accused persons openly threatened us with dire consequences stating that they were influential persons and that no police action could be taken against them if we lodged any complaint.

Due to the brutal attack we sustained injuries and immediately rushed to a nearby hospital where medical treatment was taken and injury reports were prepared, copies of which are annexed herewith. The entire incident occurred inside the club premises which is equipped with CCTV cameras, and the footage between 7:15 PM and 8:15 PM on 04.03.2026 will clearly reveal the incident. Immediate seizure of the CCTV footage is therefore necessary to preserve crucial evidence.

In view of the above facts, I humbly request your good office to register an FIR against the accused persons, seize and preserve the CCTV footage, recover the robbed gold chain and cash, and take immediate legal action while ensuring our safety from further intimidation. I am ready to cooperate fully with the investigation and identify the accused persons.
