**Subject: Complaint regarding brutal and life-threatening attack on my son by a group of miscreants.**

Respected Sir/Madam,

I, **Asha Sahani**, wife of **Rajendra Sahani**, resident of **Sahani Para, Matigara, P.S. & P.O. Matigara, Siliguri, District Darjeeling**, most respectfully submit the following for your kind consideration.

That on **04/03/2026** at about **2:00 PM**, two groups of boys started **quarrelling and fighting violently amongst themselves in front of my shop** situated at **Matigara Bazar under P.S. Matigara**. Due to the disturbance, my younger son **Bhabesh Sahani** and elder son **Santosh Sahani** along with some local people tried to intervene and requested them to stop the fight and leave the place, as the incident was creating panic in the locality. That because of the intervention and due to a large crowd gathering at the spot, **the said persons** left the place while threatening that they would return and take revenge. That later in the **evening of the same day**, the said persons **returned along with around 20 other associates at my residence at Sahani para, Matigara**, when **only my younger son was alone at home**. That the said miscreants forcibly entered the premises and suddenly **attacked my younger son in a brutal manner with sticks, iron rods and other hard objects**. They surrounded him from all sides and started mercilessly beating him without giving him any chance to escape. That during the assault, they **repeatedly struck his head and body with iron rods and sticks**, causing **bleeding from head, ears which has not stopped till now**. They continued to assault him even after he fell on the

ground in a helpless condition. That the unknown persons **dragged him, kicked him, punched him and repeatedly hit him on vital parts of his body, particularly on his head, with such force that his head was badly smashed and he suffered deep cut injuries requiring around 22-25 stitches.** That my son is unable to move his hands, feet and till now he is in unconscious state. That in an extremely inhuman act, **two of the miscreants bit him on his chest and tore off flesh from his chest,** causing severe pain, bleeding. That the entire assault was carried out with extreme cruelty and with a clear intention to kill my younger son, and the attack was nothing but a deliberate attempt on his life. That immediately after the incident, my son was rushed to Siliguri District Hospital where he was admitted in a serious condition. That considering the **critical nature of his injuries,** he has now been **shifted to a private hospital for advanced treatment.** That the **entire incident near my shop has been captured in the CCTV cameras installed in and around my shop,** which clearly shows the presence and involvement of the persons. That among the attackers I could identify the following persons: 1) **Vivek Yadav, S/o Mukesh Yadav, Resident of Promod Nagar, Pakistan More, Siliguri,** 2) **Md. Imran, Resident of Biswas Colony, Matigara, Siliguri,** 3) **Kalu s/o Md Sabir, of Biswas Colony** who brought other people to attack my son and his father is continuously calling my elder son ( Santosh Sahani ) and threatening to do the same with him, along with **many other unknown persons (around 20)** who participated in the brutal attack. That the accused persons are dangerous in nature and their actions have created extreme fear and terror in my family and locality. There is a serious apprehension that they may again attack us or threaten us.

Therefore, I humbly request you to kindly- Register an FIR against the above-named persons and their associates under appropriate sections of law and immediately arrest the attackersd involved in this brutal attack and take strict legal action so that justice may be done and the safety of my
