In producing herewith following four arrested accused persons namely (1) Roni Das- (23yrs approx) s/o Dhaniram Das of Samarnagar, Matigara PS, PO Champasari PS Pradhannagar Dist Darjeeling (2) Ratan Barman-(26yrs approx) s/o Charan Barman of Patiram jote, Kola bagan PO+PS Matigara Dist Darjeeling (3) Anmol Pradhan-(27yrs approx) s/o Lt Amit Pradhan of Takdah cantonment, Rangli Rangliot, PO Takdah PS Rongli Rongliot, Dist Darjeeling (4) Bishal Rawat-(26yrs approx) s/o Ranjan Rawat of Banewar Jote Phansidewa PO+PS Phansidewa Dist Darjeeling along with following seized articles viz:

- 1) One iron sabol measuring approx. 2 ½ feet recovered from the exclusive and Conscious possession of Roni Das.
- 2) One iron die measuring approx. 2 feet recovered from the exclusive and Conscious possession of Ratan Barman.
- 3) One iron made plus measuring approx 8 inch recovered from the exclusive and Conscious possession of Anmol Pradhan.
- 4) One Torch light recovered from Bishal Rawat

I, ASI Bikash Roy s/o Kamal Roy of Matigara PS, Siliguri Police Commissionerate do hereby lodge this complaint against the above noted persons and 4/5 others to the effect that on 08.03.2026 at 23:45 hrs received a specific source information that 6/8 miscreants have assembled at Paribahan nagar, behind petrol pump under Matigara PS, with deadly weapons and making preparation for committing dacoity to the passerby area. Accordingly I informed the matter to the I/C, Matigara PS and diarized the fact in General diary vide Matigara PS GDE No-1442 ated 08.03.26 and as per order I along with SI Srimanta Chatterjee, SI Mrinal Basunia, ASI Chandra Prakash Adhikari, C/523 Sanjib Kundu, C/219 Sanatan Chitrakar & C/868 Sujal Roy all of Matigara PS, SPC, left for Paribahan nagar, behind petrol pump under Matigara PS to work out the information in hand. This refers to Matigara PS GDE No-1442 dated 08.03.26.

At about 23.55 hrs we arrived at Paribahan nagar, behind petrol pump under Matigara PS as indicated by the source we noticed that 8/9 persons assembled there and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started shouting police and started to flee away from the spot but we the police party after somehow managed to apprehended above noted 04 (four) of them with deadly weapons in their possession but 4/5 persons managed to fled away from the spot taking the advantage of darkness and open place.

On being asked the apprehended accused persons disclosed their name and identity as noted above. During interrogation they stated that they were present there and making preparation for committing dacoity to the passerby area. On search the above noted weapon of offence recovered from their exclusive and conscious possession. On further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence with deadly weapons in the middle of the night.



Accordingly, I seized the above noted weapon of offence from their exclusive and conscious possession under proper seizure list in presence of witnesses duly acknowledged by the arrested persons and subsequently, arrested them under proper memo of arrest and observing all the formalities of arrest the whole search seizure was made on 09.03.26 between 00.15 hrs to 00.21 hrs the whole seizure was conducted under proper audio video record.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 04 (Four) arrested accused persons namely (1) Roni Das-(23yrs approx) s/o Dhaniram Das of Samarnag Champasari, PO Champasari PS Pradhannagar Dist Darjeeling (2) Ratan Barman-(26yrs approx) s/o Lt Debi Charan Barman of Patiram jote, Kola bagan PO+PS Matigara Dist Darjeeling (3) Anmol Pradhan-(27yrs approx) s/o Lt Amit Pradhan of Takdah cantonment Rangli Rangliot, PO Takdah PS Rongli Rongliot, Dist Darjeeling (4) Bishal Rawat-(26yrs approx) s/o Ranjan Rawat of Baneswar Jote Phansidewa PO+PS Phansidewa Dist Darjeeling and 4/5 others kindly arrange for its investigation.
