Subject: FIR

Sir,

With due respect, I, Smt. Priyanka Dutta, W/O. Sri. Bikash Choudhury, C/O. Sri. Shubasish Chandra Saha, resident of Bharat Singh Jote-Ranidanga, P.O.- Ranidanga, P.S.- Bagdogra, Dist.- Darjeeling, most respectfully beg to state that I have known Smt. Gita Roy, W/O. Sri. Pratap Roy, resident of Chhoto Siyavita-Ranidanga, P.O.- Ranidanga, P.S.- Bagdogra, Dist.- Darjeeling, for some time as we belong to the same locality and also because I and Pratap Roy were also colleagues working in the same company.

That on several occasions Smt. Gita Roy requested and pressurized me to provide her with personal information regarding her husband, Sri. Pratap Roy, including his whereabouts and other private matters, as Sri. Pratap Roy and I were working together as colleagues in the same office. However, I refused to provide such information as it was not appropriate for me to interfere in their personal matters. Thereafter, I informed her husband about the said matter. When Smt. Gita Roy came to know about this, she became extremely angry and started behaving aggressively towards me.

That on 01.03.2026 at about 9:00 p.m., when I was present in the market near, Kolkata Bazar, Shivmandir, along with my minor son for shopping, Smt. Gita Roy, along with her father and brother namely Mithun Sarkar, suddenly came there and started assaulting me with kicks and fists without any reason. They also threatened me with dire consequences and life threats, some local people gathered at the spot and saved me and my son, thereafter, I somehow managed to escape from the place along with my minor son to save our lives. Due to the trauma of the incident, I remained confined and could not step out of my house and was unable to go to the hospital or lodge an FIR on the same day.

That on the next day, i.e., on 02.03.2026, due to the injuries caused by the said assault, I took medical treatment at Bagdogra Gramin Hospital. Thereafter, on the same day at about 09:30 p.m., I went to Matigara Police Station to lodge an FIR against Smt. Gita Roy and her father and brother (name unknown). However, no proper action was taken and I
