Sub: - Complaint

Sir,

In producing herewith one arrested accused person namely Mintu Ghosh @ Ganesh-20yrs s/o Mithu Ghosh of Ambikanagar, Chhatpukur, PO Sahudangi, PS NJP Dist Jalpaiguri along with the following seized articles as per proper seizure list viz:

- (1) 10 (Ten) bottles of COSMOS FIFTY Deluxe whisky 50 up India made liquor each bottle containing 375 ML (3.750 Ltrs, amounting Rs- 140x10=1400/) and marked as Exhibit A on which one bottle taken as sample and marked as A1
- (2) 08 (Eight) bottles of 70 up Kanchi india made liquor each bottle containing 300 ML (2.400 ltrs, amounting Rs -50x8=400/) and marked as Exhibit B on which one bottle taken as sample and marked as B1 which was kept in one big nylon hand bag.

I, ASI Dipak Kr Chhetri of Matigara PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 09.03.26 at 19.10 hrs received a source information from Lexicon more, Opposity Trinity hotel under Matigara PS that one person namely Mintu Ghosh @ Ganesh was standing with huge quantity of liquor in his possession for selling the same in the open market for his wrongful gain without any documents/license. Diarized the fact in GD vide Matigara PS GDE No-1495 dated 09.03.26. As per your kind instruction myself along with C/523 Sanjib Kundu, C/219 Sanatan Chitrakar & C/868 Sujal Roy proceeded to the PO to work out the information. At 18.20 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him u/s 35 BNSS after issuing proper arrest memo and ground of arrest in written (The seizure was made in between 20.20hrs to 20.34hrs) the whole seizure was conducted under proper audio video record.

I therefore request you a specific case may kindly be started against the accused person namely Mintu Ghosh @ Ganesh-20yrs s/o Mithu Ghosh of Ambikanagar, Chhatpukur, PO Sahudangi, PS NJP Dist Jalpaiguri under proper section of law and arrange for investigation..
