
Sub: First Information Report

Darjeeling, would like to inform you that on 08/03/2026 at about 10.05 hours my employee Nitya Barman was found in the Bhuban Jote Primary School ground unconscious severe injured condition, he attacked by some miscreants at Bhuban Jote Primary School ground when he was enjoying along with others T20 Cricket Match in said ground, at that time following accused persons suddenly attacked him (1) Indra Mohan Singha s/o Lt. Biglal Singha (2) Samir Singha @ Atul Singha S/o. Paresh Singha r/o Nehalu Jote, P.O. Nimai, P.S. Matigara, Dist Darjeeling (3) Ramesh Munda S/o Late Surajlal Munda (4) Ram Sai Munda S/O Late Surajlal Munda all are r/o Jogivita, Khagaria Jote, P.O. Nimal, P.S. Matigara, Dist. Darjeeling (5) Akash Oraon s/o, Late Motu Oraon r/o Jogivita, Khagaria Jote, P.O. Nimal, P.S. Matigara, Dist. Darjeeling, they are all together attacked him with a sharp cutting weapon (like Torowal) and a big Iron rod they hit him his face and bodies and as a result he sustained severe injuries on his bodies and he lying in the Bhuban Jote Primary school play ground with unconscious condition with bleeding from his nose and head with serious conditions, accused persons are intent to murdered him, and then local people shouted and rescue him and matters inform to the matter to all and one Rajesh Oroan taking him in Matigara Govt Hospital for his treatment with a serious condition and Govt. Hospital advised do C.T. Scan and Xray due to severe injuries caused gravius hurt by dangerous weapons and also advised for better treatments is require and then he shifted in Annadaloke Hospital, Seyoke Road, Siliguri for better treatments now he is very critical condition laying in there, they also snatched wrist watch of Nitya barman and also cash Rs 5000/- (five thousand) from his pocket.
