Sir,

In producing herewith three arrested accused person namely Md. Prem (29 years s/o. Md. Rajuddin of Vill. Biswas colony, PO+PS. Matigara, Dist Darjeeling (not verified) along with the following seized articles under seizure as per seizure list:

(i) One transparent plastic zip-lock packet containing suspected to be Brown Sugar weighing 286 grams and marked as Exhibit-A.

I, SI Mrinal Basunia, s/o. Sri Manmatha Basunia of Matigara PS under Siliguri Police Commissionerate do hereby lodged this written complaint against above mentioned accused person to the effect that on 10.03.26 at about 21.25 hrs, received a reliable source input that one person was standing and moving with suspicious motie with huge quantity of brown Sugar at Paribahan nagar under Matigara PS area for delivering the same to his designed customers at Siliguri area for their wrongful gain. The matter was diarized in Matigara PS vide Matigara PS GDE No. 1560, dated 10.03.26 and subsequently, I informed the matter in written to the I/C Matigara PS, SPC and being directed, myself along with SI Srimanta Chatterjee, ASI Dipak Chhetri, ASI Bikash Roy, Const/868 Sujal Roy, C/219 Sanatan Chitrakar, all are Matigara PS with investigation kit left for Paribahan Nagar under PS Matigara by govt. vehicle to verify the veracity of the information and waiting there vide Matigara PS GDE no. 1561 dated 10.03.26 and M.C.C No- 662/2026, Dated 10.03.26.

Under this circumstance any search warrant or authorization cannot be obtained without affording opportunity for the concealment of evidence or facility for the escape of the offender.

Thereafter we reached at Paribahan nagar and meanwhile called two independent witnesses namely (1) Sikandar Chand Gupta, S/O. Suresh Prasad Gupta (Ph-7866030414) and (2) Kanchan Barman s/o. Lt. Krishna Barman (Ph. No. 7584019915 both of Matigara bazar, PO+PS. Matigara, Dist Darjeeling and disclosed our identity and informed them about the information in hand and requested them in writing to accompany us in the whole process during search and seizure, if any and they gave in writing about their approval to accompany Police during raid, search and seizure.

Being accompanied by source and the witnesses, on being pointed by source at about 21.55 hrs we found one person standing with suspicious motive at Parking place of Paribahan nagar. On seeing the Police party the suspect person try to escape from the place. But we detained the said person back side of Paribahan nagar and we disclosed our identity and the information in hand and stated him that he will be searched in person for the purpose. At this, he disclosing his name and address as noted above. He is admitted that he has illegally possessed brown sugar in his possession for selling the same to his designed customers as per requirement for his wrongful gain.

I then gave him written notice to be searched in presence of Spl. Executive Magistrate. Then he agreed to be searched in presence of Spl Executive magistrate. Accordingly, I informed the matter to Sri Manojit Sarkar, I/C Matigara PS, SPC, as a Spl Executive Magistrate, regarding the interception of the accused person suspected to be possessed Brown Sugar and requested him to come at Paribahan nagar, Matigara to remain present and to supervise the search and seizure as soon as possible.

Accordingly at 22.30 hrs Sri Manojit sarkar, I/C Matigara PS, SPC, as a Spl Executive Magistrate, SPC arrived at the spot as a Spl Executive Magistrate, SPC as he was present in Paribahan nagar and subsequently, under his supervision in presence of witnesses the process of search of the detained person for conducted following all formalities keeping his decency and recovered the above noted article from the exclusive possession of right side of Pant pocket of above noted accused person. Subsequently, being demanded in presence of Sri Manojit sarkar, I/C Matigara PS, SPC, as a Spl Executive Magistrate, SPC the detained person failed to produce any valid document in support of possessing of the brown sugar.

Thereafter, I weighted the recovered packet with the weighing instrument and found (i) One transparent plastic zip-lock packet containing suspected to be Brown Sugar weighing 286 grams which was kept right side of Pant pocket of above noted accused person. Then, I seized the above noted article at the spot under proper seizure list duly signed by the independent witnesses as shown by the accused person. I also labeled and sealed all the articles in presence of Sri Manojit Sarkar, I/C Matigara PS, SPC, as a Spl Executive Magistrate, SPC and witnesses and accused persons. The whole process of seizure was made in between 22.40 hrs to 22.55 hrs on 10.03.26.

Being further asked, the apprehend person admitted in presence of Sri Manojit Sarkar, I/C Matigara PS, SPC, as a Spl Executive Magistrate, SPC, and other witnesses that he procured the brown sugar clandestinely from elsewhere for the purpose of selling the same in high rate to their designed customer for his personal gain by illegal means. He also disclosed that he has been dealing in such business of procuring and selling of brown sugar illegally for last few months under the leadership of one Rohit pandit, Doli Khatoon both of Biswas colony and Sanjay Mandal of Panchkelguri of Dist Darjeeling.

Then, I arrested the above noted accused person namely Md. Prem (29 years s/o. Md. Rajauddin of Vill. Biswas colony, PO+PS. Matigara, Dist Darjeeling after observing all formalities and informing the ground of his arrest and issued necessary Memo of Arrest.

From the above noted facts and seizure of incriminating articles it is quite evident that the arrested accused person is involved in procuring and selling of brown sugar illegally contravening the norms of NDPS Act. The whole process during search, seizure and arrest was video graphed by the videographer Sri Somnath Chatterjee (Ph. No. 9064648755), S/O. Sushil Chatterjee of Vill. Arabinda pally, Gokhel road, W. no. 22, PO. Rabindra nagar, PS. Siliguri, Dist. Darjeeling.
