Subject: Written Complaint

Respected Sir,

Most humbly I, Sri Kaushik Saha, S/o. Chittaranjan Saha, resident of "Sai Niwas", Ramkrishhna Jote, Panchanan Sarani, New Rangia, Matigara, Siliguri, District- Darjeeling, West Bengal - 734001, do hereby make this written complaint before you stating as follows :

1. That on 08.03.2026, my son namely Trineesh Saha's Birthday party was organised at my above mentioned residence and to attend the same many of my son's friend were present at my house.
2. That after the party was over as it was already very late at night the driver of my HYUNDAI CRETA namely Prabhat Chandra Sarkar & Mercedes GLE 350 D 4MATIC car driven by my son Trineesh Saha left my house to drop some of his friends including one of his friend namely Anubhab Saha @ Anubhab Saha Ray S/o. Mintu Saha Ray, r/o. Pachagarh, Kokrajhar, Assam-783345, in the said car bearing registration no. WB-74-BU-1700 and WB-74-AS-1000 respectively.
3. That while they were around Lal Singh Primary School and were about to reach Phansidewa More, suddenly some 7 to 8 persons came in front of the cars and started hitting the both vehicle with fists, iron rod, brick, bamboo sticks etc.
4. That seeing the same my son's friends who were in the vehicle along with the driver became very scared and came out of the vehicle to stop those persons from damaging the vehicles but when the driver of my vehicle namely Prabhat Chandra Sarkar

asked them as to why they were damaging the vehicle, they instantly instead of stopping themselves from further damaging the vehicles all of them started abusing Prabhat Chandra Sarkar with filthy languages and then started hitting him with fists, iron rod, brick, bamboo sticks etc. on his head.

5. That watching the driver getting beaten up my son namely Trineesh Saha who was in a separate vehicle following the aforesaid car and his friend Anubhab Saha @ Anubhab Saha Ray S/o. Mintu Saha Ray, r/o. Pachagarh, Kokrajhar, Assam-783345, instantly rushed to protect the driver from those persons but the said persons started hitting them with fists, iron rod, brick, bamboo sticks, knife etc. in a very cruel manner.
6. That it is important to mention herein that the said persons hit my son's friend Anubhab Saha @ Anubhab Saha Ray S/o. Mintu Saha Ray, r/o. Pachagarh, Kokrajhar, Assam-783345, and my driver Prabhat Chandra Sarkar to such an extent that they suffered grave injuries in their head.
7. That it is also important to mention herein that the said persons also snatched away gold chain from Anubhab Saha's neck and a cash amount of Rs.5000/- from my driver's pocket. Not only that, their ulterior motive was to make a serious attempt to murder them and to snatch away the vehicle but luckily the local people hearing such hue and cry intervened into the matter and the said persons instantly fled away from the spot.
8. That thereafter instantly Anubhab Saha @ Anubhab Saha Ray S/o. Mintu Saha Ray, r/o. Pachagarh, Kokrajhar, Assam-783345, was taken to BPHC, Matigara and my driver Prabhat Chandra Sarkar North Bengal Medical College and Hospital where they were given emergency medical assistance by the doctors.
9. That it is important to mention herein that after the incident I did some local enquiry and found out that those 7 to 8 unknown

persons included (1) PRADIP BARMAN, S/o- Tapan Barman, (2) MADAN ROY, S/o- Raghu Roy, (3) MAYON SINGH, S/o- Madhab Singh, all are resident of Ramkrishna Jote and identities of the rest of the other miscreants are still unknown. In addition to such it has also come to my knowledge that aforesaid persons are a part of an organised crime syndicate who are usually engaged in these kind of crimes including murder, kidnapping etc. and such activities of them has created a sense of terror amongst the local people.

10. That from the acts and conducts of (1) PRADIP BARMAN, S/o- Tapan Barman, (2) MADAN ROY, S/o- Raghu Roy, (3) MAYON SINGH, S/o- Madhab Singh, all are resident of Ramkrishna Jote and 7-8 another unknown miscreants it is crystal clear that all of them hatched up a deep rooted criminal conspiracy and with a clear intention of snatching away my vehicle and theft by killing my son and Anubhab Saha @ Anubhab Saha Ray S/o. Mintu Saha Ray, r/o. Pachagarh, Kokrajhar, Assam-783345, and my driver Prabhat Chandra Sarkar and my son's other friend who were present inside the car hit them with fists, iron rod, brick, bamboo sticks, knife etc and snatched away the gold chain of my son and Rs.5000/- Cash from my driver's pocket which are heinous crimes under the penal provisions of law.
11. That as I was busy with the medical treatment of Anubhab Saha @ Anubhab Saha Ray S/o. Mintu Saha Ray, r/o. Pachagarh, Kokrajhar, Assam-783345, and my driver Prabhat Chandra Sarkar that is why there is a slight delay in lodging this instant complaint.

In the circumstances I reasonably apprehend and believe that those (1) PRADIP BARMAN, S/o- Tapan Barman, (2) MADAN ROY, S/o- Raghu Roy, (3) MAYON SINGH, S/o- Madhab Singh, all are resident of Ramkrishna Jote and 7-8 another unknown miscreants may again commit similar kind of


