1. That I am the actual recorded owner of Land Measuring 2.22 acres , recorded

vide a registered sale deed being No.I 647 /2023 Dated 31/07/2023 recorded
in Book No.I, volume No.0403-2023, Pages from 11959 to 11974 in the
office of DSR Darjeeling and also land Measuring 0.74 acres , recorded in
khatian No.1546 and 2828, Plot No.311 L.R, 207 R.S, Mouza Khoplashi,
JL.No.21 under Matigara Police Station, vide a registered sale deed being
No.I 440 /2009 in the office of DSR Darjeeling.
2. That on 26-02-2026 I came to know that the above mentioned accused and
others in conspiracy with land mafia has created a false and fabricated Sale
Deed being No.I 191/2026 Dated 13/01/2026 for the Mouza Pachkulguri and
another Deed being No.I 190/2026 Dated 13/01/ for Mouza Khoplashi both
sale deeds registered at ADSR Siliguri-II at Bagdogra, Dist Darjeeling with
the help of false imperson to illegally transferred my property to the
1.MR.MILAN SUBBA S/O MAITA SINGH SUBBA R/o Upper Kani kalimpong
I, PO and Ps Kalimpong, Dist Kalimpong, 2. Mrs. Nandita Tamang W/o
Rupen Tamang r/o-Salbari, Methibari, PO Salbari, Ps Pradhannagar, Dist

Sale Deeds the impersonated person has sign in english and I have not
appeared before the Registry office Bagdogra on 13/01/2026 so it is very
clear that the impersonated person has been brought to ADSR
Bagdogra Office for signature and executing the false Deed.
4. That I came to know the said Accused No. 1.LMD JAHID S/O Jamaluddin
2. MALA CHHETRI W/O- Bharat Chhetri, 3. SHYAMAL ROY S/O NAGENDRA
NATH ROY, 4. DILIP MUNDA S/O-PRADIP MUNDA, 5.PURAN SHARMA
S/O-BISHNU KANTA SHARMA, are engaged in this type of illegal activities
of creating illegal and forged deed and several complaint has been
lodged against them in different Police Station.
5. That I am attaching all the documents proving my original Ownership
and as well as the false and fabricated two Sales Deed.

Therefore I request you to register this complaint an F.I.R under relevant sections of cheating, forgery, impersonated, using false document as genuine to misguide the government officials and other offences committed against the above named accused persons and investigate this matter immediately to prevent further illegal transfer of my property.
