Sir,

I, ASI Subir Sen of Siliguri P.S. under Siliguri Police Commissionerate, do hereby lodged this written complaint against the arrested accused persons namely; (1) Pradip Das @ Paltu 34 yrs S/O late Manik Das R/O Tikiapara, Matangini- II, Ward no- 28, PS- Siliguri, Dist- Darjeeling (2) Nandu Tirkey (27) yrs S/O Late- Saharay Tirkey R/O Chhattaranjan Colony, Bagrakot, Ward no- 20 PS- Siliguri, Dist-Darjeeling. (3) Dipak Paswan @ Motra (39 yrs) S/O Phuden Paswan R/O- Fuleshwari unnayan Colony, North Bharat Nagar, ward no- 24 PS- Siliguri Dist- Darjeeling along with following seizure articles; (i) One steel made knife measuring approx Nine (09) inches, recovered from the possession of Pradip Das @ Paltu (which was on his waist in right side) (ii) One Iron made wrench measuring approx 10.5" inches, recovered from the possession of Nandu Tirkey ( it was on his hand), (iii) One Iron made Crowbar measuring approx 28.3 inches, recovered from the possession of Dipak Paswan (it was on his hand) , I beg to report that on 11.03.2026 at 23.25 hrs received a reliable source information that about 10/12 anti socials being armed with deadly weapons assembled at P & T Goli, New Milan Pally, ward no- 25, under PS- Siliguri, for making preparation to commit dacoity in a house at Milan Pally ward no- 25 area under Siliguri PS. Accordingly I informed to I/C Siliguri PS and noted in general diary (vide Siliguri PS GDE No. 582 Dated 12.03.2026) and as per his direction I along with, ASI Rabin Lama, ASI Minhaj Al Kader, Const 160 Soumen Sarkar, of Siliguri PS, SPC and reliable source with investigation Kits left for spot to verify the veracity about the source information after briefing to accompanied officers and force properly. Around 23.35 hrs we reached at new Milan Pally, near P & T more, ward no. 25 under Siliguri PS and kept our vehicle at considerable distance and looking for witnesses, but nobody were present due to night hours. Then, as per guidance by source I along with other officers and force moving towards P & T Goli, and on being shown by the source, we could see a group of persons standing and were whispering in subdued suspicious manner. Somehow they seeing our Police team and they tried to flee away from the spot but our police team managed to apprehend the above noted persons and others managed to fled away in an advantage of darkness. On interrogation they disclosed their identity as noted above and they also admitted that they along with others assembled at spot for making preparation to commit dacoity at tonight in a house at Milan Pally, ward no- 25 under Siliguri PS. On being searched I recovered the above noted articles from the exclusive and conscious possession of the above noted arrested accused persons, accordingly I seized the same from possession of them. duly sign by the accused as well as witnesses (The searched and seizure and labeled was made in between 23.40 hrs & 23.58 hrs on- 11.03.2026). From the above noted facts, and circumstance there is reason to believe that accused persons had assembled there with deadly weapons making preparation to commit dacoity in a house at Milan Pally area under Siliguri PS.


