This is to inform you that I Agnik Acharjee S/o Tapan Acharjee resident of Rabindra Nagar, Ward no. 22 would like to bring to your kind notice that around 10:30pm to 11:30pm on 13th March, 2026 Sujan Sotradkar, Bapi and 5 others had hit me very badly altogether while I was going to my home from Rathkhola more towards Rabindra Nagar and asked money from me and snatched away my gold chain and my purse. I somehow managed to go to a shop named Phorbat which is situated at Rathkhola More. I was all alone while they were hitting me with glass rods and sticks. Thereafter a local called my Joy Mandal called my mother and my mother rescued me from that spot. It had been many time earlier too that they threatened me but this time as I was all alone they had together hidden me mercilessly. I would request you to take strict action against those persons and do the needful.
