Sub: Written Complaint

Dear Sir,

With due respect I the undersigned would like to inform you that yesterday, i.e., on 13.03.2026 at night at about 10:30 pm when my son Sri Abhijeet Das @ Bapi was returning from his working place at house and on the way at Rabindra Nagar Main Road, Opposite of Maa Manashkamona Kali Temple, one Agnik Acharje, Son of Sri Tapan Acharje at Rabindra Nagar, Post Office – Rabindra Sarani, Police Station – Siliguri suddenly resisted my son and started to abuse him in filthy language just without any rhyme and reason and on protest as made by my son, he started to assault me and my son by fist and blows and for that my son sustained blood injury on upper side of his nose which caused the bleeding and he also snatched the gold chain from his neck and forcibly take away a sum of Rs. 25,300/- (Rupees Twenty Five Thousand Three Hundred) from his jeans pocket.

In the meantime some local people tried to resist my son and they also protested the said illegal act of Agnik Acharjee but he became very ferocious and violent and abused by saying that my son belongs to a Lower Caste Community and my son alongwith my other family members have no social status to stay in the locality where he like the Upper Caste of Brahmin resides and he also threatened my son that he has the capacity to throw out my son and my other family members from our locality in presence of the public in general and said Agnik Acharjee

uttered those threatening intentionally just to humiliate my son addressing his caste.

After the said incident my son has been brought to Siliguri Sadar Hospital for his treatment and due to his serious condition and blood injury he has been taken admission and after the treatment he has been discharged today but my son has been suffering with severe pain and injury till now and his treatment is going on and he is still lying on the bed. Soon after the said incident I could not inform the matter to you due to the engagement in regard to the treatment of my son.

Under the above circumstances I would like to request you to investigate the matter and do needful for the ends of justice.
