Sir,

With reference to the subject cited as above, regretfully brought to your kind notice that despite our earlier complaints to the police and having our own round the clock security guard and CCTV surveillance, some miscreants are still trespassing to our complex and trying to steal anything possible, as if they have no fear of police/security guard.

Earlier many valuable items such as Iron fencing, copper strips, copper earth plates, etc., have been stolen from the 200kW Medium Wave Transmitter field area and boundary wall Iron angle fencing.

Recently, from Akashvani Civil Construction Wing adjacent to our Transmitter building, many valuable items such as Steel Almirah, Ceiling fan, collapsible gate, and supporting railings of the stairs have also been stolen by unknown persons.

A recent incident occurred on 11/03/2026 at around 11:00 A.M., when an unknown person pilfered an iron grill from the boundary wall fencing and ran away when he was seen by the on-duty staff.

The 200kW Medium Wave Transmitter complex is a vital installation of the Govt. of India and such incidents may lead to major theft cases in the future, disrupting the broadcast of programmes of national interest.

It is therefore requested that the matter may kindly be looked into and that frequent police patrolling, particularly during the night, may be arranged.

This is for your kind information and necessary action so that such incidents may be prevented in the future.
