Sir,

In producing herewith two (02) accused persons namely (i) Md Saddam (24 yrs) S/O Late Md Allauddin of Koila Depot. Ward No-07, Khalpara, PS- Siliguri, Dist. Darjeeling and (ii) Raja Mahato (24 yrs) S/O Dulu Mahato of Koila Depot. Ward No-07, Khalpara, PS- Siliguri, Dist. Darjeeling under arrest along with the following seizure articles viz :- (i) One black colour back pack styled as "hp" having five compartments which contains one transparent white colour packet, containing 292 grms of Brown sugar marked as Exhibit "A", recovered and seized from the joint possession of above mentioned two accused persons (ii) One switched off android Mobile Phone "TECNO" Marked as Exhibit "B" recovered and seized from the possession of accused Md Saddam (24 yrs) S/O Late Md Allauddin of Koila Depot. Ward No-07, Khalpara, PS- Siliguri, Dist. Darjeeling and (iii) One android Mobile Phone "VIVO" having IMEI No 86111005387413273 Marked as Exhibit "C" recovered and seized from the possession of accused Raja Mahato (24 yrs) S/O Dulu Mahato of Koila Depot. Ward No-07, Khalpara, PS- Siliguri, Dist. Darjeeling. The ground of arrest duly been communicated with them. I, SI SI Tinku Modak S/O Ujjal Modak of Pradhan Nagar PS, Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted two (02) arrested accused persons namely (i) Md Saddam (24 yrs) S/O Late Md Allauddin of Koila Depot. Ward No-07, Khalpara, PS- Siliguri, Dist. Darjeeling and (ii) Raja Mahato (24 yrs) S/O Dulu Mahato of Koila Depot. Ward No-07, Khalpara, PS- Siliguri, Dist. Darjeeling to the effect that on 14.03.2026 at 21:45 hrs I received a reliable specific secret source input that two persons would be come to Darjeeling More area under PS - Pradhan Nagar, Dist. Darjeeling with huge quantity of illegal Narcotic Contraband (Brown Sugar) in their bag to deliver the same to their design customers.

Accordingly, the matter was diarized in PS General Diary vide Pradhan Nagar PS GDE No. 878 dated 14.03.2026 and I informed to you in writing. Subsequently, being directed by you at about 21.55 hrs myself along with ASI Prabal Sarkar, ASI Biplab Kr Das, ASI Anwar Abedin and others force of Pradhan Nagar PS, SPC left for Darjeeling More under Pradhan Nagar PS, Dist. Darjeeling without any search warrant or authorization for search which could not be possible to obtain from a competent authority for sudden development of such a sensitive information and also for not giving them opportunity for concealment of evidence or facility for their escape. This refers to Pradhan Nagar PS GDE No. 879 dated 14.03.2026 and M.C.C. No. 478/26 dated 14.03.2026. I also informed one Videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No 22, PS- Siliguri, Dist- Darjeeling over telephone and requested him to come to Darjeeling More under PS Pradhan Nagar, Dist. Darjeeling with his video camera for the purpose of video graph if required. On the way, I briefed all the Police personnel properly sharing them the nature of information in hand. I also contact with RT Van officer ASI Jagannath Roy and share the information to him and directed him to come to Darjeeling More to accompany us.

At around 22.05 hrs on 14.03.26 we arrived at Darjeeling More under PS- Pradhan Nagar, Dist. Darjeeling and contacted with my source while he informed me that the persons who possessing illegal Narcotic Contraband (Brown Sugar) will come to Darjeeling More to deliver the same to their customers shortly. Then, I requested two available independent persons namely (i) Lalan Sha (54 yrs) S/O Late Brojnath Sha of Siv Nagar Colony, Darjeeling More, PS- Pradhan Nagar, Dist. Darjeeling (Mobile No 9609880219) and (ii) Prakash Sha (50 yrs) S/O Madan Sha of Durgaguri, Ward No-45, PS- Pradhan Nagar, Dist. Darjeeling (Mobile No 6294964189) and shared the information with them and requested them to remain present at the spot and act as independent witness if any search would be made upon which they agreed and give their consent verbally to co operate with me and to act as witness. I also issued notice to the above mentioned two independent witnesses. In the mean time RT mobile officers ASI Jagannath Roy along with force came to the spot at Darjeeling More to assist us. At around 23.30 hrs hrs I received an information from my source that the persons possessing illegal contrabands was coming to Siliguri from Kaliachak side by a passenger vehicle and got down at opposite to Labanya Kata and coming towards Darjeeling More by foot. I shared the information with my raiding team. After a while being pointed by my source, I noticed that two persons were coming towards Darjeeling More from Darjeeling More Labanya Kata Side. Accordingly, we cordoned the place from every possible corner and at around 23.35 hrs we managed to detain both of them at Darjeeling More under PS- Pradhan Nagar, Dist. Darjeeling with one black colour back pack in the possession of one suspect.

Then, we disclosed our identities as Police personnel (as 4/5 police personnel were in civil dress for our convenience) and informed them regarding the information in hand. On interrogation, the detained persons disclosed their name and identity as (i) Md Saddam (24 yrs) S/O Late Md Allauddin of Koila Depot. Ward No-07, Khalpara, PS- Siliguri, Dist. Darjeeling and (ii) Raja Mahato (24 yrs) S/O Dulu Mahato of Koila Depot. Ward No-07, Khalpara, PS- Siliguri, Dist. Darjeeling and also disclosed that they were possessing the Brown Sugar in their bag and came there to deliver the same to their designated customer. Then, I issued notice in writing to them whether they wanted to search their bag in presence of an Executive Magistrate or any Gazetted Officer as per norms u/s 50 of NDPS Act, upon which they agreed to be searched in presence of any of the above noted officers. Accordingly, I informed the matter to you over mobile phone and requested you to arrange an executive Magistrate or Gazetted Officer to supervise the entire process of search and if required seizure. At around 00.30 hrs on 14.03.26 the above named videographer arrived at the spot with his camera. Accordingly, I served a notice to him for videograph the entire process of search and seizure if required. Further at around 00.35 hrs on 14.03.26 you arrived at the spot at Darjeeling More under PS- Pradhan Nagar, Dist. Darjeeling to perform the duty of gazetted officer being the I/C of Pradhan Nagar PS and informed me that no Executive Magistrate was available due to odd hours of night and as a gazetted officer you are legally authorised to give order to search bag of the suspects. Then, I served a notice to you to supervise the entire process of search and if required of seizure. Thereafter on camera, I offered both the independent witnesses noted above and the detained persons to search our Police Personnel as per provisions of law but they denied searching the Police personnel. Then, in presence of you and independent witnesses noted above, I searched the bag under the possession of the above mentioned two detained persons and recovered one black colour back pack styled as "hp" having five compartments which contains one transparent white colour packet, containing 292 grms of Brown sugar. On demand in presence of you and independent witnesses, the above named detained persons failed to produce any valid document/papers for possessing or carrying such huge quantities of Narcotic substance (Brown Sugar). On further grilling, they confessed their guilt and stated that they procured the said quantities of Brown Sugar clandestinely from Kaliachak, Malda for the purpose of selling the same in high rates to his selected customers in siliguri for their wrongfull gain. They also stated that they are running such business illegally for their wrongful gain.

Accordingly, I seized the said articles viz :- (i) One black colour back pack styled as "hp" having five compartments which contains one transparent white colour packet, containing 292 grms of Brown sugar marked as Exhibit "A", recovered and seized from the joint possession of above mentioned two accused persons (ii) One switched off android Mobile Phone "TECNO" Marked as Exhibit "B" recovered and seized from the possession of accused Md Saddam (24 yrs) S/O Late Md Allauddin of Koila Depot. Ward No-07, Khalpara, PS- Siliguri, Dist. Darjeeling and (iii) One android Mobile Phone "VIVO" having IMEI No 86111005387413273 Marked as Exhibit "C" under proper seizure list in presence of you and independent witnesses and obtained their signatures which is acknowledged by the accused persons. Subsequently, I sealed and labelled the seized contraband articles in presence of you and independent witnesses and the above noted accused persons at the spot. The entire process of search, seizure and labelling were made under the coverage of a video graph executed by the videographer namely Somnath Chatterjee, S/O Sushil Chatterjee of Arabinda Pally, Gokhel Road, Ward No. 22, PS. Siliguri, Dist.- Darjeeling in between 00.40 hrs to 01.30 hrs on 15.03.26 as per norms of BNSS.

From the above noted facts and seizure of incriminating articles, it is quite evident that both the detined persons namely i) Md Saddam (24 yrs) S/O Late Md Allauddin of Koila Depot. Ward No-07, Khalpara, PS- Siliguri, Dist. Darjeeling and (ii) Raja Mahato (24 yrs) S/O Dulu Mahato of Koila Depot. Ward No-07, Khalpara, PS- Siliguri, Dist. Darjeeling are involved in procuring and selling Narcotic substance "Brown Sugar" illegally contravening the provisions of NDPS Act. Then, I arrested them after observing all formalities of arrest, informing them regarding the ground of their arrest and brought to Pradhan Nagar PS for further investigation. I also informed to the friend of the accused Md Saddam namely Tipu Sk over Mobile phone having Mobile No 8617098415 regarding arrest of Md Saddam and inform to the mother of accused Raja Mahato namely Mira Mahato over Mobile Phone having Mobile No 8972174920 regarding arrest of her son Raja Mahato.

Under the above fact and circumstances, I pray before you that a specific case under proper sections of law may kindly be registered against the arrested persons namely (i) Md Saddam (24 yrs) S/O Late Md Allauddin of Koila Depot. Ward No-07, Khalpara, PS- Siliguri, Dist. Darjeeling and (ii) Raja Mahato (24 yrs) S/O Dulu Mahato of Koila Depot. Ward No-07, Khalpara, PS- Siliguri, Dist. Darjeeling and kindly arranged its investigation.
