Respected Sir,

I, Goutam Das, son of Gopal Krishna Das, resident of Sitala Para, Siliguri, Ward No. 31 of Siliguri Municipal Corporation, P.O. Siliguri Bazaar, P.S. New Jalpaiguri, District Jalpaiguri, Pin - 734005, most respectfully submit this complaint before you for your kind consideration and necessary action.

I am the proprietor of Dipayan Construction and my registered office is situated at Holding No. H/1453, Sitala Para, Siliguri, Ward No. 31 of S.M.C., P.O. Siliguri Bazaar, P.S. New Jalpaiguri, District Jalpaiguri, Pin - 734005. I work as a contractor and general order supplier and at present I am engaged in executing several government projects which have been sanctioned in my favour after proper verification of all my documents by the concerned government authorities.

Mithun Biswas (also known as Gopal), son of Monmohato Biswas, resident of Shaktigarh, Road No. 10, Ward No. 31 of S.M.C., P.O. Siliguri Bazaar, P.S. New Jalpaiguri, District Jalpaiguri, Pin - 734005, is known in the locality as an antisocial person. It is widely known that several criminal cases have been registered against him and he is allegedly involved in various illegal activities in the locality.

Yesterday at about 11:30 A.M., the said Mithun Biswas came to my registered office situated at the above-mentioned address and started threatening and intimidating me. During that time he demanded money from me and stated that if I wanted to continue my construction and contract work peacefully in the locality, I would have to pay him protection money regularly. He further threatened me that if I did not comply with his demand, he would murder me at any time.

Today at about 11:30 A.M., the said Mithun Biswas again called me on my mobile number 7586093603 and once again threatened me over the phone. During the said call he demanded that I must pay him 10% of the total contract quotation amount immediately, failing which he threatened that he would kill me at any time.

Due to the continuous threats and intimidation by the said Mithun Biswas, I am living in constant fear and mental distress. Considering his conduct and

reputation in the locality, I strongly apprehend danger to my life as well as to the lives of my family members.

Under these circumstances, I humbly request you to kindly take immediate and necessary legal action against the said Mithun Biswas and provide necessary protection to me and my family members, as I genuinely fear that he may cause serious harm to us at any moment.

I shall remain ever grateful for your prompt action in this matter.
