Sir,

I, Smt. Mallika Sarkar, wife of Sri. Anup Das, resident of Bankim Sarani, East Lake Town, Deshbandhu Para, Ward No. 33 of S.M.C. (Siliguri Municipal Corporation) Post Office- Siliguri Town, Police Station- New Jalpaiguri, PIN-734004, District- Jalpaiguri, would like to inform you that on 16.04.2017 my marriage was registered according to the Special Marriage Act, 1954 and on 17.02.2020 the marriage between me and my Husband namely Anup Das S/o- Shital Das resident of Bankim Sarani, East Lake Town, Deshbandhu Pata, Ward No- 33, P.O- Siliguri Town, P.S- Bhaktinagar, District- Jalpaiguri according to the hindu Rites and Customs at my parental House at ShantiNagar, Bowbazar, P.O- Dabgram, P.S- Bhaktinagar, District- Jalpaiguri and on the very next day of my marriage i.e. on 17.01.2020 I was taken to my matrimonial home at Bankim Sarani, East Lake Town, Deshbandhu Para, Ward No. 33 of S.M.C. (Siliguri Municipal Corporation) Post Office- Siliguri Town, Police Station- New Jalpaiguri, PIN-734004, District- Jalpaiguri by my husband and we started living there our conjugal life.

It is to mention here that at the time of my marriage, my parents have given gold and Silver ornament to my husband and me along with clothing and other household articles. and have also given Gold ornaments to my mother - in law namely Smt. Gauri Das.

Soon after our marriage, my Husband and my mother-in-law requested me not to conceive pregnancy till the elder brother of my husband gets married and becomes father. Then she politely threatened that if I conceive pregnancy before the marriage of my brother-in-law, they would have face immense humiliation in the society and then it would be difficult for them to keep me in my matrimonial home. I had no clue what to do in such a situation as because I was newly married wife and I had no other option so decided to follow the instruction of my mother-in-law as a responsible wife and daughter-in-law.

After few month of my marriage, my mother-in-law Smt. Gauri Das and My father-in-law Shital Das alongwith Sri Pankaj Das (brother - in law), and my Husband started demanding more dowry and when I denied to ask my parents for the demand of further dowry all the above named persons have started

mental and physical torture upon me. It is further to state here that my husband and the above named in-laws have adopted the policy of severe torture to oust me from my matrimonial house but I every time some how managed not to get ousted from my matrimonial house, Being a Hindu lady and considering the prestige of the family members of my husband I have not lodged any complaint before any authority concern with a hope that my husband and in-laws may rectify themselves in near future and till to date residing at my matrimonial house.

It is pertinent to mention here that my husband never gave any money to me for my personal expenses, neither he provides any essential article which is very much require for me. I had to ask for everything to my parents and my parent always try to manage those articles as per their capacity and provide me. On December 2022 one day I was shivering in fever and requested my husband over phone to bring 'paracetamol tablets' for me. However, my husband returned home at night without any medicine and when I wanted to know the reason, he said my father-in-law instructed him not to waste money in medicines and the fever will be automatically cured in due course of time. Hearing such versions of my husband I got shattered from within. And then I called my mother and told her to bring those Paracetamol for me.

In the month of November 2024, when I was cooking in the kitchen, my mother-in-law without any reason started shouting at me and asked me to leave the kitchen and not to enter there again. When, I wanted to know the reason of such misbehavior she replied that she does not like me ; her son brought me as a commodity to use me in this house as maid and if I dare to ask any questions I would be subjected to physical torture as they were regularly doing upon me soon after our marriage. my mother in law also threatened not to speak any word regarding this incident to my husband. I accepted such incident as irony of fate and decided to perform my marital obligations just to save my matrimonial relation.

That on 04.01.2026 my mother received a notice from Learned Additional District Judge 1st Court, Jalpaiguri. Thereafter, I come to know that my husband by using false and concocted stories filed a Matrimonial Suit against me seeking for Divorce which is registered as Matrimonial Suit being No. 351 of 2025 and after that I immediately contacted with an Advocate and on 07.01.2025 I duly appeared through my Learned Advocate in the said suit which is still pending before the Additional District Judge 1st Court, Jalpaiguri.

It is to be mention here that I am living at my matrimonial house since my marriage till to date and in due time the above mentioned Matrimonial Case have been filled against me by my husband nothing just to oust me from my matrimonial house.

It is pertinent to mention here that almost last 6 months they did not provide me any food, I have to travel to my parental house for having food on

each and every day. Neither my in-laws allow me to park my scooter in the house nor they are allowing me to enter in house Temple for offering prayer. One day when I went to the kitchen my father-in-law scolded me and told me that if I have to eat at my matrimonial house then, my parents would have to pay them Rs. 2,00,000/- or else they will never provide me food.

On 02-03-2026 about 8 pm, I was in my room at my matrimonial house all of sudden above mentioned In-Laws entered into my room and started physical torture upon me without any reason and try to throw me out from my matrimonial house but I again some how saved myself from above named in-laws, during their physical assault they were shouting at me that if I do not leave the matrimonial house then they will put some narcotics, intoxicating substance in my room as well as in my personal bag and they will call the police and falsely implicate me in some criminal case hearing this I forcefully shut the door of my room at that time. and my Father In Law, Mother In Law and Brother In Law is threatening me either to leave the matrimonial house or to give them money otherwise they will kill me and will make it a case of suicide.

I am a helpless lady and finding no other alternative but to lodging this complaint against above named persons before your good authority to take legal action and I further request you to take appropriate steps to punish my husband and In-Laws and to assure my safety and security in my matrimonial home
