Sir,

In producing herewith the following accused person namely Raju Oraon (M-40) S/O Late Balli Oraon of Pabitra Nagar, P.S. Pradhan Nagar, Dist. Darjeeling under arrest and the following articles under seizure viz :- (i) 01 (one) Goods Carrier (Truck) having Registration No. WB-76-2123 loaded with illegally mined river bed materials along with its Key under proper seizure list. I, ASI Prabal Sarkar of Pradhan Nagar PS, SPC do hereby lodge this written complaint against the the above noted arrested accused person namely Raju Oraon (M-40) S/O Late Balli Oraon of Pabitra Nagar, P.S. Pradhan Nagar, Dist. Darjeeling and the owner of the said seized vehicle having Registration number WB-76-2123 to the effect that on 16.03.2026 at 12.20 hrs myself along with force left the PS to perform P.C Mobile van duty vide Pradhan Nagar PS GDE No 956 dated 16.03.2026. During my duty, I received a secret source information that one Truck having registration WB-76-2123 loaded illegal river bed materials coming from Meletarry Ghat, Mahananda river bed and proceeding towards Champasari. Accordingly, I informed the fact to you over mobile phone and as per your kind order and direction myself along with force had been to Champasari More under PS Pradhan Nagar, Dist. Darjeeling. At around 12.55 hrs we detained the said truck displaying number plate WB-76-2123 loaded with illegal River bed materials at Champasari More under PS-Pradhan Nagar, Dist.- Darjeeling and also found that the driver was inside the cabin of the said truck. On being asked the driver of the said vehicle disclosed his identity as noted above. On demand he failed to produce any valid documents in respect of illegal river bed materials loaded in his vehicle. On further interrogation he disclosed that he with the help of his owner mines such river bed materials from Mahananda River by illegal means with a view to sale the same to their design customers for their illegal gain. Accordingly, I seized the above noted vehicle having registration number WB-76-2123 loaded with illegally mining river bed materials under proper seizure list and subsequently arrested the driver of the said vehicle after maintaining all the formalities of arrest and brought to Pradhan Nagar PS for further investigation. The search and seizure was made in between 13.05 hrs. to 13.15 hrs. at the spot under the coverage of videography as per norms of BNSS.

Under the above noted fact and circumstances, I therefore, I pray before you that a specific case under proper section of law may kindly be started against the arrested accused person namely Raju Oraon (M-40) S/O Late Balli Oraon of Pabitra Nagar, P.S. Pradhan Nagar, Dist. Darjeeling and the owner of the said seized vehicle having Registration number WB-76-2123 and arrange for its investigation.
