In producing here with the seized articles viz:-

1) Total 01(One) Number of Hindustan Petroleum Domestic Empty gas Cylinder.

Under proper seizure list. I ASI Pranab Kumar Majumdar of Enforcement Branch, Siliguri Police Commissionerate do hereby lodge a written complaint against Sanjib Ray (30 yrs) S/O Ram Suresh Ray of Kulipara, ward no.-1 P.S- Pradhanagar, Dist- Darjeeling owner of "Vinayak Family Hotel and Restaurant Shop" located at Sevak Road P.S- Bhaktinagar, Dist- Jalpaiguri who was illegally procured the domestic Gas cylinder at his Hotel and Restaurant for commercial purpose without any valid documents or license to the effect that today i.e. 16.03.26 at about 12:30 hrs vide Enforcement Branch SPC GDE No. 82 Dt. 16.03.26 in course of Mobile Gas Checking at Bhaktinagar Area. Arrived and above noted Restaurant styled as "Vinayak Family Hotel and Restaurant Shop" situated at above mentioned address and found using the domestic Gas cylinder at his Restaurant for preparing food items for using commercial purpose for his wrongful gain.

Hence I informed the matter to ACP EB, SPC and as per his instruction I along with officer and force conducted raid in the restaurant run by Sanjib Ray (30 yrs) S/O Ram Suresh Ray of Sevak Road P.S- Bhaktinagar, Dist- Jalpaiguri. During search found worker of Restaurant making food items by using the domestic HP gas cylinder without any valid documents for commercial purpose, On demand they failed to produce any valid documents in support of using the HP gas cylinder in Restaurant styled as "Vinayak Family Hotel and Restaurant Shop" for commercial purpose.

It is crystal clear that the said person namely Sanjib Ray (30 yrs) S/O Ram Suresh Ray of Sevak Road P.S- Bhaktinagar, Dist- Jalpaiguri is using the Domestic gas cylinders in his Restaurant for his wrongful gain. As per local enquiry it came to light that the above noted person storing and using gas negligently with respect to fire or combustible matter, which may endanger human life or likely to cause hurt or injury to person at that locality area. Sanjib Ray does not have any valid Documents regarding above seized articles. Thus the above noted accused person violated the provision of West Bengal Cooking Gas (License and Control) order 1985 and other Government Orders.

Accordingly I seized the above noted seized articles as per seizure list in presence of witnesses namely 1) Raj Lala (19) S/O Bablu Lala of BRI colony P.S- Pradhannagar Dist- Darjeeling. 2) Sanjay Gupta (44) S/O Lt. Survan Gupta of Uppar Bhanunagar PS- Bhaktinagar, Dist- Jalpaiguri. The seizure was made in between 13.10 Hrs to 13.45 Hrs.


