I, Sri Tapas Bishui, Divisional Engineer(E) & Station Manager, Hakimpara CCC, WBSEDCL, Siliguri do here by lodge complaint against Rajendra Kumar Agarwal Tenant, (Ph No.-9434062381, 9266681264 & 6295699359), Ram Krishna Samity Building, Panitanki More, Sevok Road, S, Siliguri, Dist- Jalpaiguri, 734001 for having committed offence as stated here under.

On 16.03.2026 at about 13:57 p.m. acting on a source information I, along with (1) Sri Bijay Lakra, S.E., S&LP Wing, Darjeeling Region, WBSEDCL, (2) Sri Bhaben Roy, S.O., S&LP Wing, Darjeeling Region, WBSEDCL, (3) Sri Biswajit Ghosh, Linesman, Hakimpara CCC and other officials of WBSEDCL entered the Commercial premises of Rajendra Kumar Agarwal (Tenant) and inspected service installation, metering installation of Consumer ID 402942332 in the name of Rajendra Kumar Agarwal (Tenant). During inspection it was found that electricity was being used unauthorisedly & illegally by Rajendra Kumar Agarwal (Tenant) by reconnecting the deemed disconnected service line of the metering installation that was disconnected previously on 27.01.2025 due to non-payment of outstanding energy bill.

As unauthorised reconnection of the disconnected service line and metering installation was detected the energy meter make Bentec Bhartia Engineers Pvt L, serial no.- BE0386898 installed against Con Id. 402942332 seized by preparing a formal seizure list duly signed by Rajendra Kumar Agarwal (Tenant) and witnesses. The copy of the seizure list handed over to Rajendra Kumar Agarwal (Tenant) and his signature obtained as token of receipt.

As Rajendra Kumar Agarwal (Tenant) have committed offence u/s 138(1)(b) of Electricity Act 2003 by using electricity illegally & unauthorisedly by reconnecting the deemed disconnected service line, you are requested to take cognizance of the same by treating this complaint as FIR.
