Sir,

I, SI Biman Ghosh of Panitanki TOP under Siliguri PS, Siliguri Police Commissionerate producing herewith one arrested accused named Rocky Roy (M/31) S/O Lt. Dinabandhu Roy of Vill- Roy Para , P.O- Roy Para, P.S- Kalna, Dist- Purba Burdwan along with seizure of (i) One iron made improvised Fire Arms with wooden butt and complete mechanism having length of 22 cm (approx)(Exhibit-A) (ii) Two live ammunitions (Exhibit-B) with a noted that seized articles duly labeled & sealed, do hereby lodge this complaint against accused. Rocky Roy (M/31) S/O Lt. Dinabandhu Roy of Vill- Roy Para , P.O- Roy Para, P.S- Kalna, Dist- Purba Burdwan to the effect that today on 18.03.2026 at about 17.15 hrs received reliable source information that one person is moving suspiciously at Mahakalpally area with a fire arms with an ulterior motive. This refers to Panitanki TOP GDE no 507 dated 18.03.2026. According, I intimated the fact to OC Panitanki TOP as well as I/C Siliguri P.S and as per his kind direction myself along with ASI Debasish Das, ASI Amal Barman and ASI Minhaj Al Kader departed from TOP to work out the information, At about 17.55 hrs, I along with aforesaid officer & force reached at Mahakalpally area and found that one unknown person was loitering there as identified by the source, We then to secure his detention falling all possible precaution proceeded towards him. The youth on seeing the police persons in uniform started to flee away from the spot. We then chased him and somehow could be able to apprehend him. We called two local witnesses named (i) Akash Chakraborty (M/23) S/O- Surya Chakraborty of Mahakalpally, W/no.44, P.S- Bhaktinagar, Dist- jalpaiguri (ii) Amit Das (M/26) S/O- Supen Das of Kamarpaar, P.S- Kotwali, Dist- jalpaiguri and disclosed them the fact and requested to co-operate with police. Accordingly, in my response, they consented and in their presence on being asked, he disclosed his name and address as noted above. In presence of above noted witnesses, I searched the above noted person and recovered. (i) One iron made improvised Fire Arms with wooden butt and complete mechanism having length of 22 cm (approx)(Exhibit-A) (ii) Two live ammunitions (Exhibit-B) from his exclusive possession as mentioned above which he concealed at the left side of his waist. Accordingly I seized the same under a proper seizer list from 18.05 to 18.25 hrs in presence of witnesses duly signed by them and signed by me too and also I labeled the seized articles properly and arrested him accordingly after apprising him the ground of arrest and observing proper formalities. On further interrogation, he made incoherent statements. On demand he failed produced any valid license or documents in support of said arms and ammunitions and on further grilling, he confessed his guilt and discloses that he had procured the said illegal arms and live ammunitions from Bihar side for the purpose to sell in Siliguri area.

After knowing the fact local people are annoyed with him and there was no scope to serve the notice U/S- 35(3) BNSS. Hence, I arrested him U/S- 35(1) BNSS as he violated the provision of Arms Act. There is sufficient reason to believe that the accused person noted above was roaming there with an ulterior motive to commit cognizable offence.

So, I pray that a specific case has been initiated against the above noted arrested accused person named Rocky Roy (M/31) S/O Lt. Dinabandhu Roy of Vill- Roy Para, P.O- Roy Para, P.S- Kalna, Dist- Purba Burdwan under proper section of law and kindly arrange for its investigation.


