Sir,

In producing herewith arrested lady accused person namely Dipa Rai (42 yrs) W/O Suraj Rai of Singhijhora near Indra Maya Primary school , PS- Bhaktinagar Dist- Jalpaiguri along with seized articles vize i) 17 (Seventeen) sealed bottles of Tuborg Premium Beer containing 650 ml each , amounting of Rs.160/- each, marked as Exihibits- A, ii) 01 (one) sealed bottles of Tuborg Premium Beer containing 650 ml was taken up from exhibit -A as sample for a examination, marked as Exihibits- A1, iii) 02 (two) sealed bottles of Blenders Pride whiskey containing 750 ml each , amounting of Rs 1020/- each, marked as Exhibits-B, iv) 01 (one) sealed bottle of Blenders Pride whiskey containing 750 ml was taken out from Exhibits-B as sample for examination, marked as exhibits-B1, as per seizure list.

I, ASI Dipak Karmakar S/O Late Dulal Karmoakar of Bhaktinagar PS, SPC do here by lodged a written complaint against above noted arrested lady accused person namely Dipa Rai (42 yrs) W/O Suraj Rai of Singhijhora near Indra Maya Primary , PS- Bhaktinagar Dist- Jalpaiguri to the effect that on 18.03.26 at 12.45 hrs acting on secret source information that the above noted person was busy to sale foreign liquor illegally in her shop styled as Swagatam restaurent situated at Taribari under PS- Bhaktinagar Dist- Jalpaiguri in order to clandestinely dispose the same. Accordingly the fact is diarized in GD vide **Bhaktinagar** PS GDE no.954 dated 18.03.26 and informed the fact to I/C Bhaktinagar PS. As per direction of I/C Bhaktinagar PS, I along with ASI Dhruva Mishra , C/1426 Prosanta Kr. Dutta, LC/1348 Menuka Rana both of Bhaktinagar PS left for Taribari under PS- Bhaktinagar to verify the veracity of the information vide Bhaktinagar PS G.D.E No.955 dated 18.03.26. On reaching at 13.15 hrs at the mentioned P.O and as identified by source cordoned the above noted area where she was selling illegal alcohol. On seeing the police party the above noted person tried to escape from the spot but we managed to apprehend the above noted person with the help of lady force and on interrogation, she disclosed her identity as noted above. On being asked she stated that she used to sale the foreign liquor to her desigh costomer at her above mentioned shop without any valid documents. On being asked she could not produce any valid documents in respect of the said liquor. On searching i) 17 (Seventeen) sealed bottles of Tuborg Premium Beer containing 650 ml each , amounting of Rs.160/- each, marked as Exihibits- A, ii) 01 (one) sealed bottles of Tuborg Premium Beer containing 650 ml was taken up from exhibit -A as sample for a examination, marked as Exihibits- A1, iii) 02 (two) sealed bottles of Blenders Pride whiskey containing 750 ml each , amounting of Rs 1020/- each, marked as Exhibits-B, iv) 01 (one) sealed bottle of Blenders Pride whiskey containing 750 ml was taken out from Exhibits-B as sample for examination, marked as exhibits-B1 and accordingly I seized the same as per seizure list as she has violated the norms of Bengal Excise Act for selling the said seized articles without any valid license. She also stated that she is doing this liquor

business since long for her wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 13.35 hrs and 14.20 hrs. As such I arrested him U/S-35(1) BNSS after observing all sorts' of rules after mainlining her decency.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused person namely Dipa Rai (42 yrs) W/O Suraj Rai of Singhijhora near Indra Maya Primary , PS- Bhaktinagar Dist- Jalpaiguri along with seized articles under proper section of law and arrange for its investigate.
