With due regards, I, **SMT. PAROMITA GHOSH**, Wife of Sri Debasis Ghosh, Daughter of Goutam Ghosh, Resident of Aurobindapally, Matangini Hazra Sarani, Near Bharati Sebak Sangha Club, Siliguri, P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling, Pin: 734006., would like to lodge this written complaint before your good authority to the effect that **SRIDEBASIS GHOSH** is my legally married husband and I am his legally married wife and our marriage was solemnized on 04/06/2013, according to Hindu Rites and Customs, after observing all formalities of a Hindu Marriage on and from my parental house situated at Aurobindapally, Matangini Hazra Sarani, Near Bharati Sebak Sangha Club, Siliguri, P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling, Pin: 734001.

Sir soon after the solemnization of our marriage I went to my matrimonial house situated at East Rabindra Nagar, Near Tilak Sadhu More, P.O. Rabindra Sarani, P.S. Bhaktinagar, Dist- Jalpaiguri, Pin: 734006 and started to reside there with my husband and my in-laws. At the time of marriage, many various valuable articles and golden jewelries were given by my family to the family of my husband as per their demand and wishes and all the golden jewelries and other valuable articles are still in the custody of my mother-in-law. Sir, few days after the marriage, I started to notice that the behavior of my husband and my in-laws towards me drastically changed and my husband and my in-law members started to show their dissatisfaction with the items given at the time of marriage by my father and my relatives.

Sir, since the inception of my marriage, I have been subjected to continuous physical and mental torture by my husband and his family members which were further supported by his family members. Furthermore, my in-laws, along with certain other relatives of my husband, regularly used abusive, offensive, and derogatory language towards me and treated me with utmost disrespect. Sir, It is also pertinent to mention that my mother-in-law repeatedly taunted me by stating that she had never approved my marriage and had never wanted me marry her son and moreover, my husband since the very

and offensive language and directed me to leave my matrimonial home and return to my parental house and my brother-in-law, namely Subhasis Ghose, further humiliated me by questioning my chastity and calling me "characterless." and then, I, informed the local police station over phone, and with the intervention of the Ashihar Out Post Police Personnel, I was rescued and the situation was brought under control. Sir, since the last nine years my husband has deliberately refused to maintain any physical relationship with me and even told me to remarry or work as a "sex worker" to satisfy my desires and conspiracy with my in-laws, he shifted me to a separate small room and refused to stay with me, compelling me to reside there alone with my minor son and my husband has also neglected and refused to discharge his legal responsibility to maintain me and my minor son.

Sir, due to such constant mental and physical torture and being subjected to tremendous Domestic Violence at the hands of my husband and his family members, I, finding no other alternative, have preferred an application under the Protection of Women from Domestic Violence Act, 2005 in the year of 2025, before the Ld. Court of Law at Siliguri Sub-Divisional Court vide Misc. Case No. 246 of 2025, which is currently pending before the Ld. Court and after receiving summons of the said case, my husband and my in-laws got more angry and started to create immense pressure upon me and started to threaten me with dire consequences of killing me and ending my life permanently and also threatening me continuously that they have huge nexus with many anti socials persons of the society and they will not hesitate to kill me soon if I do not leave my matrimonial house with my minor child immediately. Sir everyday they are trying to oust me from my matrimonial home by using force and pressure and I apprehend that my husband and his family members may soon attack upon me mercilessly and will throw me away from their house

I, therefore, request you to investigate into the matter and please take appropriate strong legal action against my husband namely Debasis Ghosh, father-in-law namely Sri Salil Kumar Ghose and mother-in-law namely Smt. Namita Ghosh, brother-in-Law namely Sri Subhasis Ghose as per the provision of law and obliged thereby.
