Sir,

In producing herewith Two (02) accused persons namely i) Rajib Laskar (25 years/M) s/o Gopal Laskar of Paschim Dhantala, Fulbari, PS- NJP, Dist- Jalpaiguri and ii) Sanat Barman @ Deba (18 yrs./M) SO-Late Paramesh Barman of Murder More, Paschim Dhantala, PS- NJP, Dist- Jalpaiguri under proper arrest memo and the following articles under seizure.

- i) One (01) iron made improvised small fire arm (one shooter) measuring approx length 60" with iron butt, body barrel, trigger, firing pin, firing hammer recovered from the accused namely Rajib Laskar marked as Exhibit A.
- ii) One (01) nylon bag from the possession of accused person namely Rajib Laskar in which Exhibit A was kept in (Marked as Exhibit B)
- iii) One (01) round of 7.62 mm live ammunition recovered from left side pant pocket of accused person namely Sanat Barman @ Deba (Marked as Exhibit C)

In this regard, I ASI Nilam Swarnakar presently posted at New Jalpaiguri Police Station, Siliguri Police Commissionerate beg to report that today i.e. on 17.03.26 at 14.15 hrs, I received a specific secret information that 02 (Two) persons were roaming at Chhobavita, Near Jorapani Bridge under NJP PS for selling the firearms to designed customer. Accordingly, I diarized the information in General diary vide NJP PS GDE No 793 dated 17/03/2026 and informed the fact to you. As per your kind order and direction at 14.30 hrs vide NJP PS GDE No- 794 Dated 17/03/2026 myself along with ASI Khagen Barman, ASI Munna Ahmed, C/453 Uttam Dey, C/1462 Sajan Tamang, VP 13 Jamirul Islam, VP/08 Laxman Roy all of NJP PS left for Chhobavita, Near Jorapani Bridge under NJP PS with investigation kits to work out the information by Govt. vehicle to verify the veracity of the information. I managed two independent witnesses namely (i) Dayal Roy S/O- Late Naren Roy of Chhobavita, PS- NJP, Dist- Jalpaiguri and (ii) Tarun Kumar Taparia S/O- Malchand Taparia of Kanchanbari, Near Wine Shop, PS- NJP, Dist- Jalpaiguri and after disclosing our identity we disclosed the purpose and requested them to accompany with us as independent witness. After being at the area i.e Chhobaavita, Near Jorapani Bridge under NJP PS and as indicated by the source we noticed that two (02) persons were standing there in suspicious way. On seeing police personnel approaching towards them, both tried to flee away from the spot and after a hot chase we managed to apprehend them. On interrogation, they disclosed their identity as noted above. As per our source information, they possessed 01 improvised small Fire arms with one (01) live ammunition. Hence, immediately we searched the persons and recovered One (01) improvised small fire arms (One shooter) measuring approx length 60" with iron butt, body barrel, trigger, firing pin, firing hammer concealed in nylon bag Black from the possession of Rajib Laskar and One (01) round of 7.62 mm live ammunition recovered from left side pant pocket of accused person namely Sanat Barman @ Deba in presence of witnesses namely (i) Dayal Roy S/O- Late Naren Roy of Chhobavita, PS- NJP, Dist- Jalpaiguri and (ii) Tarun Kumar Taparia S/O- Malchand Taparia of Kanchanbari, Near Wine Shop, PS- NJP, Dist- Jalpaiguri. On demand both of them failed to produce any valid document in support of such possession of the said arms and ammunition. As the above noted accused persons violated the provision of Indian Arms Act.

Accordingly the arms and ammunitions were seized after preparing a seizure list duly signed by above noted witnesses and accused persons. The seized arms and ammunition were properly labelled and arrested the above noted accused person under proper memo of arrest and the ground of arrest has duly been duly communicated with him.

Hence, I pray to you considering the offence a specific case may kindly be started against the arrested accused persons namely i) Rajib Laskar (25 years/M) s/o Gopal Laskar of Paschim Dhantala, Fulbari, PS- NJP, Dist- Jalpaiguri and ii) Sanat Barman @ Deba (18 yrs. /M) SO-Late Paramesh Barman of Murder More, Paschim Dhantala, PS- NJP, Dist- Jalpaiguri and arrange for its investigation. Seized articles were handed over to the Makhana Officer with proper seizure list after maintaining all formalities.
