Sir,

In producing herewith following seized articles as per seizure list viz :- (i) One goods carrier vehicle (Truck) white and blue colour having registration No. WB/73/D/8016 loaded with illegally mined river bed baterilas along with its key.

I, ASI Md. Anwar Abedin of Pradhan Nagar PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against the driver of the above mentioned seized vehicle having registration number WB/73/D/8016 to the effect that on 17.03.2026 at 10.35 hrs onwards, I was engaged to perform Spl. Mobile van duty vide GDE No 1024 dated 17.03.2026. In course of my Spl. Mobile van duty at around 11.35 hrs I received a specific secret source information that one Truck bearing Reg. No. WB/73/D/8016 loaded with illegally mined river bed materials is coming towards Champasari side from Mahananda river bed, Natun Bazar area via Dakshin Palash under Pradhannagar P.S without any valid documents. Accordingly, I informed the fact to you over mobile phone and as per your kind order and direction myself along with force had been to Dakshin Palash area under Pradhannagar P.S. At around 12.05 hrs while we reached at Dakshin Palash and from a considerable distance we noticed that one truck loaded with river bed materials was coming towards Champasari. Accordingly, we proceeded towards the said truck but seeing the Police van the driver of the said truck parked the truck on the road and fled away. We tried to apprehend the driver but in vain. After physical verification it is found that the truck is loaded with illegally mined river bed materials. I searched the driver of the truck as well as the owner of the truck but nobody could able to provide any information regarding driver and owner of the truck. During local enquiry it could be revealed that the driver of the vehicle having Regn No WB/73/D/8016 mines such illegal river bed materials from Mahananda River illegally and loaded the same in his vehicle having Registration Number WB/73/D/8016 with a views to sale the same to his designed customers for his illegal gain. Accordingly, I seized the said detained truck having Registrtrion Number WB/73/D/8016 loaded with illegally mined river bed bed materials under proper seizure list in presence of independent witnesses at the spot. The seizure was mede in between 12.25 hrs to 12.50 hrs under the video coverage of vedigraphy as per norms of BNSS.

Under the above circumstances, I pray before you that a specific case under proper sections of law may kindly be registered against the driver of the vehicle bearing registration number WB/73/D/8016 and arrange for its investigation.
