Sir,

I, Smt. Suman Yadav (Roy), W/o Sri Ajay Yadav and D/O. Sri Ramjiwan Roy, presently residing at under co Ashok Roy of Debidanga, P.S. Pradhannagar, District Darjeeling, like to bring to your notice the following facts:

1. That my marriage was solemnised with Ajay Yadav, S/O. Lt. Harinarayan Yadav of Rajbari Para, P.S. Kotwali, P.O. & District Jalpaiguri on 13.12.2021 at Sona Lodge, Champasari according to Hindu rites and customs. It was an arranged marriage. In the aforesaid marriage, my father had to pay Rs. 1,80,000/- in the Bank Account of my husband Ajay Yadav and Rs. 1,50,000/- in cash as dowry, and one golden chain weighing 10 gms, Golden Ring Weighing 5Gms, to my husband as per demand of my husband and also golden chain, utensils of brass and stainless steel, furnitures, clothing materials etc.

After the aforesaid marriage, I went to my matrimonial home at Rajbari Para, Jalpaiguri and started residing in a joint family with my husband and in-laws. But immediately after my marriage, my mother-in-law, sister-in-laws and husband, who is a habitual drunkard, started tremendous mental and physical torture upon me on the false plea that the furnitures, and brass and stainless steel utensils given in my marriage were not up to the mark and as such they started to assault me every now and then. My husband took away my golden ornaments and gave it to his eldest sister Smt. Madhu Yadav W/O. Shankar Yadav. Being compelled by such physical and mental torture, my father had to give all the brass and stainless steel utensils and other clothing materials for the second time.

2. That after 3/4 months of my marriage, I conceived and hearing this news of my pregnancy, my husband, mother-in-law, eldest sister-in-law Madhu Yadav, youngest sister-in-law Puja Yadav, brother-in-law Bijay Yadav, all started abusing me and all of them started to assault me and threatened me to terminate my pregnancy or else they will kill me. Since I did not agree to their such illegal proposal, their grudge and anger increased and they constantly continued to physically torture and assault me so that my unborn child die in my womb. However, in this way I gave birth to a male child named Swastik Yadav on 25.11.2022. But after the birth of my son, they did not provide the minimum food and care to me and my son. My husband is a habitual drunker and even after the birth of my son he did not change his behavior and forced me to do all the household works Since I could not do all their ordered jobs/works due to the look after of my small newborn baby. my husband forcibly brought me to Siliguri and left me in the bus terminus and went back. I somehow went to my sister's house and informed them about all such tortures, after which my father and other relatives called my husband and asked him about the matter. My husband apologized and took me and my child back to my matrimonial home.
3. That thereafter also my husband, mother-in-law, both sister-in-laws and brother-in-law again started to torture me inhumanly. I came to my sister's house on the occasion of Rakhi and then my husband called me over the mobile and threatened me not to return to my matrimonial home or else they will kill my son and myself, after which I had been staying in my sister's house under compelling circumstances.
4. That thereafter I received one notice of Legal Aid Jalpaiguri and when I appeared there on 16.12.2025, my husband and his relatives forcibly obtained my signatures on some papers on the point of threat of killing my son.
5. That there after I was asked to go to Jalpaiguri Court on 10.3.26 and then I came to know that my husband has manufactured the documents of a Matrimonial Suit for Divorce and as such I refused to appear in the said suit and returned back to Siliguri.


6. That on 15TH March 2026 at about 8:00 PM, my husband, mother-in-law, his sisters Madhu Yadav, youngest sister Puja Yadav and her husband Shankar Yadav, and their brother Bijay Yadav came to my sister's residence and forcibly tried to take my son with them and since I protested to their such illegal activities, all the aforesaid accused persons started to assault me with fists, blows and kicks in front of my son and hearing my hue and cry my sister and other people gathered there and somehow rescued me from their grip.

After this all the accused persons went back threatening to come back and teach me a lesson very soon, after which I am passing my days in great anxiety and fear.

I, therefore, request you to take immediate necessary steps against my husband, mother-in-law, sister-in-laws Madhu Yadav, Puja Yadav, brother-in-law (Jamai) Shankar Yadav and Bijay Yadav (Debar) as per law and oblige.
