Respected sir,

I, **Smt. Lalo Kujur**, Wife of Late Mangru Kurjur, resident of Sisa bari, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling, would like to state you the following facts:-

1. That one **(i) Sujal Jaiswal**, Son of not known to me, **(ii) Vishal Singh** Son of not known, **(iii) Arminda Barman**, Son of not known, **(iv) Anan Gossai**, Son of not known **(v) Bishu**, Son of not known along with 3 / 4 persons whose name are not known to me, all are resident of Devidanga, P.O. Champasari, P.S. Pradhan Nagar, Dist. Darjeeling, on 15.3.2026 at about 7:30 p.m. when my son Ajesh Kujur along with his one friend namely Nibin @ Sabin Roy, Son of Chutlal Roy, resident of Sisabari, Champasari, P.S. Pradhan Nagar, Dist. Darjeeling was coming through milanmore, champasari side at that time the above named miscreants namely **Sujal Jaiswal, (ii) Vishal Singh, (iii) Arminda Barman, (iv) Anan Gossai, (v) Bishu**, along with 3 / 4 bikessuddenly came in their respective bikes(Royal Enfield) bearing No. WB74BK 5395, and other bikes whose number due to darkness I cannot read at that time, stopped me and started demanding cash money so that they may buy alcohol for their enjoyment hearing this my son and his friend denied to give money to them. Hearing the denial from my son they started abuses **(in hindi languages saying “ Sala Aadiwasika Aulad tum Paisa Kyunahidega, tumko yah**

**perahne keliye paisa Dena hi parega, nahi to yeha perahne nahi dega, Sala Jangli Log, Bhagyha se)** and threatening my son in filthy and offensive languages without any reason, seeing this my son protested them, in the meantime one Sujal Jaiswal all of sudden started hitting with a (stick made of iron which they specially made and carried for committing such type of crime, and in the said bike they arranged a particular place for the said iron rod) there after all the above miscreants also involved in the scene and all those caught hold my son and started physically assaulting my son by fists, blows and by kicks. They mercilessly assaulting my son almost 15-20 minutes seeing this some passersby gathered on the spot helped them and rescued them. At that time seeing the passersby gathering on the spot they fled away from the spot but before that, they snatched silver chain from the neck of my son.

It, is to be mentioned here that in that mercilessly scuffling my son's left side lower jaw has been fully broken and his friend Nibin @ Sabin Roy got very lethal cut injury on his head and left side of his face for which he has given stiches on his head and also have to take 6 stiches his left side of his face. And still my son is admitted in North Bengal Medical College and Hospital. Said Sujal Jaiswal, Arminda Barman and Vishal Singh tightly caught hold my son and the with a planning and intention to kill my son and his friends continuously attacked with their iron rod on the head of my son and his friends so that they may die.

Sir, had those passersby not interfered in the matter they would definitely killed my son and his friends.

2. That as my son is still in doctor's observation. Siliguri Civil Hospital seeing my son serious condition referred to N.B.M.C.H, so I was badly involved in such tight schedule, as such I could not lodge FIR in due time which may kindly may condone.

I, therefore, requested you to kindly take necessary legal steps in the aforesaid matter for the commission of such heinous crime by the miscreants namely **Sujal Jaiswal, (ii) Vishal Singh (iii) Arminda Barman, (iv) Anan Gossai, (v) Bishu.**
