Subject: Complaint regarding assault, criminal intimidation, and threat to life

Respected Sir,

I, Sujit Gupta, s/o Late Prabhunath prasad, resident of Ward No. 46, P.O. Champasari Kali Mandir, Opposite Ice Factory, P.S. Pradhan Nagar, Siliguri – 734003, beg to state that due to ongoing matrimonial disputes, my wife **Roshni Gupta** (D/o Jai Prakash Gupta, resident of Banarhat, District Jalpaiguri – 735202) is residing separately, which has caused me considerable mental distress. For maintaining my mental peace, I have been regularly attending meditation sessions at Panics Healing Centre, Sevoke Road, opposite ASG Hospital, Siliguri since last one year.

On 17.03.2026 at about 3:00 PM, when I visited the said centre, I initially faced difficulty in entering as the gate was locked. After entering, I came to know that my wife was also attending classes there. At that time, her brother **Sanjeev Gupta** (resident of Gokul Apartment, Ward No. 40, Punjabi Para, Siliguri) obstructed my entry, pushed me, and threatened me with dire consequences, including threats to my life. He also called several persons who approached me in a hostile manner. Being apprehensive about my safety, I left the place.

Further, on the same day at about 11:00 PM near Masjit Gali Pradhan Nagar, 2-3 unknown persons stopped me and questioned me alleging that I had spoken against **Sanjeev Gupta**. Despite my denial, they physically assaulted me. One of them brought an iron rod and attempted to hit my head. While trying to protect myself, I

raised my hand and sustained serious injury. Somehow, I managed to escape and returned homewith great difficulty. As I was in severe pain and had no physical strength, I immediately went to a nearby clinic, namelyAviyan Health Centre , for medical assistance. However, the doctors there advised me to go to Siliguri Hospital for proper treatment and further medical examination.

After the said incidents, I am under severe fear and apprehension regarding my life and safety. I have strong reasons to believe that the persons who attacked me were engaged by Sanjeev Gupta and that there is a continuing threat to my life. The above incidents clearly demonstrate a grave, real, and imminent threat to my life and personal safety. Due to these incidents, I am living under constant fear and mental trauma.

Therefore, I humbly request you toKindly register my complaint/FIR against the accused persons and take immediate legal action againstSanjeev Gupta and the unknown assailants and also provide necessary protection to ensure my safety and prevent any further harm.

I shall be grateful for your prompt action.
