Subject: Written Complaint for physical and mental torture by the husband and in-laws.

Respected Madam,

With due respect I, Piyali Paul, wife of Sri Sanjay Pal, daughter of Bimal Paul, permanent resident of Tripti House, University Avenue, Opposite of Gate No. 2, Shivmandir, presently residing at Pati Colony, Road No. 8, P.O. Pradhannagar, P.S.- Matigara, Dist. Darjeeling hereby wish to lodge a complaint against my husband and his family members, including my mother-in-law namely Tripti Paul and my father-in-law namely Sri Sisir Ranjan Paul, for the cruelty and harassment that I have been subjected to after my marriage.

I was married on 09 July 2014 and as a result of the wedlock we have a son namely Nirvan Pal, he was born on 02.08.2017, he has now completed class III at Alphonsa School, Kalamjote, Matigara and will be promoted to the next class. During the marriage several gold jewelry and Cash of Rs. 1,50,000/- (Rupees One Lakh Fifty Thousand) only, furniture like bed, dressing table etc., were provided by my parents to my in-laws.

Initially though everything was running good but within few weeks of marriage I have noticed some changes in the behavior of my in-laws, my father-in-law and mother-in-law started making remarks regarding the quantum of gold jewelry provided by my parents and the quality of the other gift items they have given in my marriage, they even started insulting my parents by saying that they are not in match with their family as my parents are financially weak to them and educationally not sound like them, and when I made protest to those insult as our marriage was an arranged one and before marriage they have seen everything regarding me, then after marriage why they are saying all these?? Then they became more vulnerable and assaulted me with whatever they found in their hand.

Prior marriage I was working as a Teacher at Bari Mandir Railway School on contractual basis, but after few months of marriage my husband and in-laws started pressurizing me to leave the job and concentrate fully in the household cores as my salary was low, and to make them happy I left the said job.

Day by day the remarks became regular taunting as my in-laws started taunting even regarding my skin complexion, my education, my look, my upbringing, they even restricted to go to my parents' home and even asked me to quit relationship with all my relatives and friends from my childhood.

Soon my husband and my mother-in-law started assaulting me physically and my father-in-law in spite of noticing all these never restrained them, rather he started using slang languages against me and my parents and asked me to bear all these as I deserve these.

Initially I was shocked but later I became quite used to it when I saw my father-in-law assaulting my mother-in-law in the same way and inspite of knowing this my husband never tried to restrain him.

The birth of our son also could not bring any changes in their behavior and in fact in front of the son also my mother-in-law and my husband assaulted me on several occasions, and my father-in-law also never hesitated to use slangs against me.

Due to all these physical and mental torture I emotionally started differing from my husband and whenever I tried to talk to him he refused to listen to me rather he forcefully made sexual relation with me regularly and compelled me to take I-Pill for more than two years, which resulted in the cause of Tumor in my Uterus and which also caused heavy hormonal imbalance and whenever I dared to protest, I was assaulted with fist and blows by my husband.

While all these were going on, my in-laws chose to remain quiet and rather blamed me for all that occurred. My husband further got involved in an affair with another lady, and on confronting him while finding the proof and catching him red-handed, I was beaten up/assaulted mercilessly in front of my 7 year old son on 28.02.2026, later they have forcefully compelled me to give resignation at my present job at Daughters Wealth Tech Pvt. Ltd. on 02.03.2026, where my designation was of the Financial Advisor.

On the 1st of March, 2026 my husband took me along with him to Dhuppuri, which is the present place of his posting as Branch Manager at Ujjivan Small Finance Bank, Dhuppuri and there also he forced me to have physical relationship with him against my wish. And on 2nd of March, 2026, I returned from there and got a check-up in Matigara Hospital and thereafter took shelter at my Parents home. The very next day, my husband visited me at my Parents home and tried to convince me and my parents that I should go back to my in-laws house, and thus once again, I returned to my in-law's house, nonetheless, the ill-behavior remained un-changed, and the mental and physical torture, unbearable taunts, and the harassment continued.

As a result I am left with no other resort than to file this present complaint. I would like to humbly request you to kindly consider my circumstance and take appropriate action against my husband and my in-laws, and provide me with necessary protection.

It is to be mentioned here that at the time of marriage my parents gave me gold jewelry weighing approx. 105 grams having necklace, bangles, jhumkas, finger ring, one chain and one finger ring for groom and from the in-laws and my other relatives I got another 50-60 grams of gold jewelry and after marriage I also got 7 pair of gold earrings and withing few days of marriage all those jewelries were taken from me and later I came to know that all those are kept in a locker at NBU Branch of SBI Bank which is in the name of my in-laws.
