Respected Sir,

With due respect & humble submission, I, Smt. Debjani Dutta, w/b-Sri Abhijit Kar, D/o-Sri Dibyendu Dutta, resident of Matigara Govt. Colony, P.O & P.S. - Matigara, Dist- Darjeeling would like to inform you that I got legally married to Sri Abhijit Kar on 27-11-2024 according to Hindu rites & customs. It's an arranged marriage.

That from very beginning of my marriage, I was subjected to continuous mental & physical cruelty by my husband & his family members namely, Sri Parimal Kar (father-in-law), Smt. Arati Kar (mother-in-law) & Smt. Mahuya Kar (sister-in-law) all are resident of Bhimbhar, P.O - Madati, P.S - Phasidewa, Siliguri, Dist - Darjeeling. My husband behaved in a strange & hostile manner & frequently abused me in filthy language, humiliated me & told me that he was unhappy in this marriage & mentally tortured me by neglecting & isolating me. On several occasions, I was physically assaulted & threatened me to face with consequences that he will not allow me to live peacefully in my matrimonial home & also threatened to face legal consequences. My in-laws supported his behaviour & compelled me to adjust as their son has anger issues & ~~also~~ suicidal tendency which was not told to us before marriage & mentally harassed me by demanding dowry & all my stridhan

Therefore due to all the mental, physical & emotional harassment I was bound to leave my matrimonial house & started living in my parental house since 28th Sep 2025. I came to know that my husband Abhijit Kar is having illicit affair with his aunt (mami) & used to spend nights in her residence in Dalkhola. Despite knowing all this my in-laws told me to adjust.

My Stridhan articles (One gold necklace & earring set, two gold bangles, gold ring, 5 gold pola rings, 6 gold tarcel necklace, one bed, one almira, one alnah, one mattress, one blanket & 2 pillow, all the bedding sets, 3 trolley bags, ~~all the gift~~ brass & bronze utensils, all the gift items received from my side ^{in the wedding} as well as two gold rings, two ^{gold} earrings, two ^{gold} pola ring, 4 gold tarcel necklace, two bronze bangles & all the gift items received from the side of my husband's family are still retained by my husband & in-laws & have not been returned despite repeated demands.

We tried to communicate with them through one of our well-wisher ~~but~~ but they harassed us & used filthy language towards me & my family due to which my father ~~health~~ got ~~de~~ ill & is completely on medication & my me & family is completely stressed. My husband & in-laws have never tried to communicate further.

Therefore, I humbly request you to kindly register an FIR against my husband & in-laws as mentioned above & take immediate necessary action.
