Sir,

In producing herewith one arrested accused person namely Md Sukuruddin-32yrs s/o Lt Md Samsul of Suktigodown, PO+PS Matigara Dist Darjeeling along with the following seized articles as per proper seizure list viz:

- (1) 16 (sixteen) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ML (9.600 Ltrs, amounting Rs- 140x16=2720/) and marked as Exhibit A on which one bottle taken as sample and marked as A1

I, ASI Bikash Roy of Matigara PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 18.03.26 at 15.55 hrs myself along with force left for PS mobile duty at PS area and at about 18.40 hrs during my PS Mobile duty received a source information from Paribahannagar parking under Matigara PS that one person namely Md Sukuruddin was standing with huge quantity of liquor in his possession for selling the same in the open market for his wrongful gain without any documents/license. This refers to Matigara PS GDE No-2019 dated 18.03.26. As per your kind instruction myself along with C/523 Sanjib Kundu, C/219 Sanatan Chitrakar & C/868 Sujal Roy proceeded to the PO to work out the information. At 18.55 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him u/s 35 BNSS after issuing proper arrest memo and ground of arrest in written (The seizure was made in between 19.10hrs to 19.22hrs) the whole seizure was conducted under proper audio video record.

I therefore request you a specific case may kindly be started against the accused person namely Md Sukuruddin-32yrs s/o Lt Md Samsul of Suktigodown, PO+PS Matigara Dist Darjeeling under proper section of law and arrange for investigation..
