Sub- Written Complaint

Sir,

My husband Niren Singha, son of Late Sudhir Kumar Singha, Rabindra Sarani, College para, Shivmandir, P.O. - Kadamtala, P.S.- Matigara, District- Darjeeling, PIN - 734011 is having illicit affair with Reshmi Roy. Previously also he was having affairs with many girls with whom I have caught him red-handed in objectionable condition. Almost on every night he come in an inebriated condition and beat me mercilessly. But as I have two minor girls, thinking of them and just to save the marriage did not lodged any complaint but my neighbours and relatives know all the incidents. But for the last one year his torture has increased so much that I can not bear it any more. He regularly beats me resulting in grievous injury. Below are the some incidents when I was almost beaten to death.

On 22nd October, 2025 he punched me with his fist wearing finger ring. He hit my head with wooden block. I got injury on my head and face. My two daughters anyhow saved me. They also tried to call the Police but out of panic they did not do so.

On 22/12/2025 also he beat me mercilessly. My nose got fractured. I was treated at Medical college. I have attached the photocopies of the medical documents and pictures of my injuries with this complaint.

On 19/02/2026 I was again beaten so hard that I got four stitches on my left eyebrow, deep cut on my lips and my forehead and black marks on my whole body. That day he beat me with a heavy wooden block. My daughters have also videographed the incident of brutality on me which is saved securely. Photographs are also there. He threw the framed photographs of my deceased parents and smashed the glasses of photo frame with his shoes.



Today, i.e. 18/03/2026 also he beat me mercilessly. Anyhow I saved myself. When I was going to police station he called me over phone, abused me in filthy language and told me that he is waiting for me with a "lathi" and he would beat me to death when I would reach home.

He is very dangerous in nature and would not hesitate to kill me.

Under the circumstances I request you to treat this written complaint as FIR, initiate a case against the said Niren Singha mentioned above, arrest him, take action against them as per law and save me from his hands.
