Subject: Complaint for registering FIR regarding intentional accident, assault, and threat

Respected Sir,

I, Riya Gupta, daughter of Mohan Gupta, resident of Ram Narayan Math, Pradhan Nagar, Gurung Basti, Siliguri (M. Corp.), District - Darjeeling, West Bengal, Pin Code - 734003, most respectfully state that on 06.03.2026 at about 1:40 PM, when I was coming out after giving my examination from the University of North Bengal, Aishwariya Pathak, Daughter of Ajay Pathak, along with Payel Mandal daughter of Chanda Mandal, intentionally hit me with her Scooty bearing Registration No. WB-73R-4386, due to which I sustained serious injuries. After the accident, I was admitted for treatment by my parents, and at that time Aishwariya Pathak admitted her fault and stated that she would bear and pay all the medical expenses for my treatment." Thereafter, I was first taken for treatment to North Bengal Medical College and Hospital, then to Dr. Mohpal's Ortho Centre, and later to Star Hospital for further treatment. However, despite her assurance, she has not paid any medical expenses and is now avoiding all communication with me and my parents, and when contacted she has threatened that she will not pay anything. Due to the said act, I have suffered serious injuries, financial loss, and mental harassment.

Therefore, I humbly request you to kindly register an FIR against the said persons and take necessary legal action against them in accordance with law.
