In producing herewith two involved accused persons named Biswajit Barman, aged 26 years, s/o- Ananta Barman, resident of Panitanki, Uttar Ramdhanjote, PS- Kharibari, Dist- Darjeeling and Tanmay Barman, aged 25 years, s/o- Akhil Barman, resident of Panitanki, Bajarujote, PS- Kharibari, Dist- Darjeeling (both not verified) under custody along with the following seized articles under proper seizure list:-

- (i) One transparent plastic carry bag contains brown colour substance suspected to be Brown Sugar measuring weight 1.046 KG and marked as Exhibit- A.
- (ii) One transparent plastic carry bag contains brown colour substance suspected to be Brown Sugar measuring weight 1.047 KG and marked as Exhibit- B.
- (iii) One black colour 'American Tourister' backpack and marked as Exhibit- C.
- (iv) One black colour 'Wildcraft' backpack and marked as Exhibit- D.
- (v) One Oppo android mobile phone having IMEI No. 865106074967596 and marked as Exhibit- E.
- (vi) One Samsung android mobile phone (S23FE) (in switched off condition) and marked as Exhibit- F.
- (vii) Cash Rs. 3500/- (INR Rs. 500/- x 5 notes).
- (viii) Cash Rs. 2120/- (INR) (Rs. 500/- x 4 notes, Rs. 100/- x 1 note and Rs. 20/- x 1 note).
- (ix) One motorcycle (Yamaha) bearing No. WB74AY/7919.
- (x) One pen drive (SanDisk 32GB) contains audio-video record of search, seizure & arrest.
- (xi) Certificate u/s 63(4)(c) BSA
- (xii) Hash Value document mentioning hash value eb67a8a88b94fc43f19234e761540e7f.

I, SI Debabrata Kundu of Bagdogra PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the arrested two accused persons named Biswajit Barman, aged 26 years, s/o- Ananta Barman, resident of Panitanki, Uttar Ramdhanjote, PS- Kharibari, Dist- Darjeeling and Tanmay Barman, aged 25 years, s/o- Akhil Barman, resident of Panitanki, Bajarujote, PS- Kharibari, Dist- Darjeeling (both not verified) to the effect that today on 17.03.2026 at 18:40 hrs I was informed by O/C Bagdogra PS that on 17.03.2026 at around 18:28 hrs in course of performing scheduled naka checking duty at Panighata more SST Naka Point on AH-02 under Bagdogra PS ASI Shekhar Lama & force C/283 Dhani Barman & C/1116 Prashanta Roy had detained two persons named Biswajit Barman, aged 26 years, s/o- Ananta Barman, resident of Panitanki, Uttar Ramdhanjote, PS- Kharibari, Dist- Darjeeling and Tanmay Barman, aged 25 years, s/o- Akhil Barman, resident of Panitanki, Bajarujote, PS- Kharibari, Dist- Darjeeling with a motorcycle bearing No. WB74AY/7919. The persons had two backpacks in their respective possession. They stated that there was brown sugar inside those two bags possessed by them. This refers to Bagdogra PS GDE No. 815 dated 17.03.2026. Accordingly, after according necessary order at 18:45 hrs I along with SI Samik Paul, ASI Amit Lama, VP/01 Anselam Kujur, VP/02 Pradip Roy, CV/375 Jogesh Barman & CV/386 Kishor Ranjan Howladar left for Panighata more SST Naka Point on AH-02 under Bagdogra PS by Govt. vehicle No. WB61A/0137 with investigation kit to work out the veracity of information. This refers to Bagdogra PS GDE No. 816 dated 17.03.2026 and M.C.C. No. 115/26 dated 17.03.2026. Then, I

A two independent witnesses named MD Ramjan, aged 26 years, s/o
of Pramed Nagor, PS- Bagdogra, Dist- Darjeeling (Ph. No. 7470111840,
aged 20 years, s/o- Late Ramnagar Ray, resident of Singhjhora TE, PS- Bagdogra,
Darjeeling (Ph No. 8207774702) and issued them notice in writing to remain present with
independent witness for the purpose of search, seizure, arrest, if any. They expressed their
willingness to remain present with us as independent witness. Further, I contacted with the
Cameraman named Raju Thakur, aged 25 years, s/o- Jaharlal Thakur, resident of Ranidanga near
Camp, PS- Bagdogra, Dist- Darjeeling (Ph. No. 8670802275) and issued him notice in
writing to prepare the audio-video record of the whole process of search and seizure, if any. Under
the circumstances any search warrant or authorization cannot be obtained without affording
an opportunity for the concealment of evidences or facility for the escape of the offender. At around
15:50 hrs we reached at Panighata more SST Naka Point on AH-02. Two suspects were detained
there by ASI Shekhar Lama and his force. Then we disclosed our identity to the detainees and
asked their identity. On being asked they revealed their identities as Biswajit Barman, aged 26
years, s/o- Ananta Barman, resident of Panitanki, Uttar Ramdhanjote, PS- Kharibari, Dist-
Darjeeling and Tanmay Barman, aged 25 years, s/o- Akhil Barman, resident of Panitanki,
Bajarujote, PS- Kharibari, Dist- Darjeeling (both not verified). They confessed that they have
possessed brown sugar inside their carried backpacks. I informed them that their personal search is
to be conducted. If they require, such search will be conducted in presence of the nearest Gazetted
Officer or Magistrate. I also issued Notice u/s 50 of the NDPS Act, 1985 to them and they
expressed their willingness to be searched by any of them. Then I contacted with Shri Sajid Iqbal,
ACP, West Zone-II, SPC at 18:55 hrs about the apprehension of two suspects named Biswajit
Barman (26 years) and Tanmay Barman (25 years) suspected to be possessed with psychotropic
substance suspected to be Brown Sugar at Panighata more SST Naka Point on AH-02 and sent a
requisition requesting him to be present at the spot to supervise the process of search & seizure, if
any as a Gazetted Officer. At around 19:10 hrs Shri Sajid Iqbal, ACP, West Zone-II, SPC arrived
at the spot to supervise the process of search & seizure, if any as a Gazetted Officer. Accordingly,
he disclosed his identity as the Gazetted Officer to the detainee. He also offered the detainee to
search our Police Party as per provision of law but the detainee denied searching police team.
Then in presence of the Gazetted Officer Shri Sajid Iqbal and the two independent witnesses the
detainees were searched. On search, one black colour 'American Tourister' backpack was
recovered from the possession of Biswajit Barman. On opening the backpack, one transparent
plastic carry bag contains brown colour substance suspected to be Brown Sugar is recovered.
Further, one black colour 'Wildcraft' backpack was recovered from the possession of Tanmay
Barman. On opening the backpack, one transparent plastic carry bag contains brown colour
substance suspected to be Brown Sugar is recovered. They identified the substance as brown
sugar. On demand, in presence of the Gazetted Officer as well as the independent witnesses said
Biswajit Barman & Tanmay Barman failed to produce any valid document/license in support of
possessing of that substance suspected to be Brown Sugar which he had been carrying. Further,
one Oppo android mobile phone, Cash Rs. 3500/- was recovered from the possession of Biswajit
Barman and one Samsung android mobile phone (S23FE), Cash Rs. 2120/- was recovered from
the possession of Tanmay Barman. Thereafter, I arranged to weigh the recovered plastic carry
bags contains substance suspected to be Brown Sugar with the weighing instrument and found
measuring weight 1.046 KG & 1.047 KG respectively. On further interrogation, they confessed
that they had procured that substance suspected to be Brown Sugar from Panitanki and were
proceeding to Siliguri to deliver the consignment to their designed customer for their wrongful
gain. On interrogation they also disclosed that they have been dealing in such business of selling
Brown Sugar illegally for last 2½ months. One Biswajit Roy, s/o- Late Jiten Roy of Goursingjote,
Panitanki under PS- Kharibari, Dist- Darjeeling had informed them to deliver the consignment to
him in Siliguri. Thus when their involvement in carrying, possessing and dealing with Brown
Sugar was established, I seized the above mentioned recovered articles from their joint possession
