I, Subhajit Roy, son of Sri Sukumar Roy, permanent resident of D.B.C Road, Deshbandhu Para, Ward No. 29 of S.M.C, P.O. & P.S. Siliguri, District Darjeeling, West Bengal, most respectfully submit as follows:


That I am engaged in a hotel business at Lower Arithang, near Govt. School, P.O. & P.S. Gangtok, Sikkim, under the name and style of "Hotel Grandala", which I am running on lease basis.

That one Mir Hasan Ali, permanent resident of Birbhum, West Bengal (Mobile No. 9674877382), is presently residing at Lower Arithang, near Govt. School, P.O. & P.S. Gangtok, Sikkim, and was working as a staff in my said hotel. During the course of his employment, I came to know that he had been involved in several fraudulent activities relating to the business operations of the hotel, which led to disputes and strained relations between us.

That a few days ago, while I was present at my above-mentioned permanent residence in Siliguri, near Dada Bhai Playground under Siliguri Police Station, the said Mir Hasan Ali came there and without any provocation, wrongfully restrained me, assaulted me physically, and threatened me with dire consequences. At that time, I remained silent and did not retaliate in order to avoid further escalation of the situation.

That thereafter, on 11/03/2026, the said person again contacted me over phone and used abusive and filthy language towards me and further threatened me with serious consequences, creating fear and mental harassment. His continuous threats and conduct have caused me immense fear for my safety and well-being.

That the acts of the said Mir Hasan Ali clearly amount to offences of assault, criminal intimidation, use of abusive language which require immediate legal intervention.




Therefore, I humbly request you to kindly take necessary legal action against the said accused person in accordance with law and provide me protection from further harassment and threats.
