Sir,

In producing herewith arrested accused person namely **Biswajit Das (24 yrs), S/O - Jadav Das of Matri Sadan, Dabgram, W/No. 20, PS-Siliguri, Dist - Darjeeling** along with the following seized articles viz.

(1) 16 (Sixteen) sealed bottles of "Old Monk Deluxe Rum" containing 750 ml. each. Total 12 Ltrs.

(2) 01 (One) Nylon Bag which was used for carrying the seized articles noted in SL. No.- 1.

I, PSI. Mrityunjoy Kundu of Khalpara TOP under Siliguri PS, hereby lodge this written complaint against the above noted accused person to the effect that on 19.03.2026 at 21.45 hrs received secret source information that one person was carrying huge quantity of foreign liquor bottles illegally near Ghoshpara back side of brothel, Khalpara, Siliguri. Accordingly informed the same to O.C Khalpara TOP and diarized the matter vide Khalpara TOP GDE No. 532, dated 19.03.2026 and after as per his direction I along with, ASI Kalachand Singha, ASI. Binod Chhetry, C/1561 Sandip Modak and C/1543 Rahul Harijon left from Khalpara TOP to work out the veracity of the information. On arrival near Ghoshpara, Khalpara, Siliguri at about 22.00 hrs, being pointed out by the source, found one person was proceeding through Ghoshpara road, Khalpara carrying a Nylon bag in his hand. Accordingly we intercepted & apprehended him. Then I searched him in presence of two independent witnesses named (i) Bapi Roy (32 Yrs) S/O Bikash Roy of Tumbajote, PS-Matigara, Dist.-Darjeeling & (ii) Uttam Saha (56 Yrs) S/O Lt. Kalicharan Saha of Jyotinagar, P.O+P.S-Phasidewa, Dist.-Darjeeling and recovered 16 (Sixteen) sealed bottles of "Old Monk Deluxe Rum" containing 750 ml. each, 12 Liters in total. During interrogation the accused failed to produce any documents/license in support of the same and stated that he will sell the same illegally to the local public of Khalpara area for his wrongful gain and livelihood. Accordingly I seized the (i) 16 (Sixteen) sealed bottles of "Old Monk Deluxe Rum" containing 750 ml. each. Total 12 Ltrs. (ii) 01 (One) Nylon Bag which was used for carrying the seized articles noted in SL. No.- (i) under proper seizure list and labeled the same in presence of witnesses and duly sign by them and accused person. The seizure was made in between 22.10 hrs and 22.25 hrs. I then arrested the accused person u/s 35(1) of BNSS after explaining charges against him and communicating ground of arrest. Total value of seized articles are Rs. 4064/-.


