Sir,

In producing herewith one arrested accused person namely Ram Kumar Oraon-24yrs s/o Lt Biphai Oraon of Mirjangla jote, Patharghata PO New Rangia PS Matigara Dist Darjeeling along with the following seized articles as per proper seizure list viz:

- (1) 12 (Twelve) bottles of Haywards Bold Beer each bottle containing 650 ML (7.800 Ltrs, amounting Rs- 150x12=1800/) and marked as Exhibit A on which one bottle taken as sample and marked as A-1

I, ASI Chandra Prakash Adhikari of Matigara PS under Siliguri Police Commissionerate do hereby lodged this written complaint against the above noted arrested accused person to the effect that on 21.03.26 at 14.45 hrs received a source information from Mirjanglajote, Patharghata under Matigara PS that one person namely Ram Kumar Oraon has gathered huge quantity of liquor in his house for selling the same in the open market for his wrongful gain without any documents/license. This refers to Matigara PS GDE No-2203 dated 21.03.26. As per your kind instruction myself along with ASI Bikash Roy, C/523 Sanjib Kundu & C/868 Sujal Roy proceeded to the PO to work out the information. At 15.10 hrs we reached at the spot, sometimes after, being identified by the source our police party held raid and recovered the above noted articles from his possession. During local enquiry it came to learn that he is selling the same in open market since long for his wrongful gain without any valid documents/license. In presence of witnesses I seized the above noted articles from his possession after prepared proper seizure list and arrested him u/s 35 BNSS after issuing proper arrest memo and ground of arrest in written (The seizure was made in between 15.20hrs to 15.34hrs) the whole seizure was conducted under proper audio video record.

I therefore request you a specific case may kindly be started against the accused person namely Ram Kumar Oraon-24yrs s/o Lt Biphai Oraon of Mirjangla jote, Patharghata PO New Rangia PS Matigara Dist Darjeeling under proper section of law and arrange for investigation..
