Most Humbly, I Md. Sohrab, Son of Md. Umer, aged about 25 yrs, Resident of Vivekananda Nagar, Koyla Depo, Near Madrasah, Ward no-7 of SMC, P.O & P.S-Siliguri, Dist-Darjeeling do here write this complaint before you against persons namely Persons namely 1. Md.Subiya 2. Md. Jubra 3. Md Nasim all are resident of Swami Nagar Colony, Near Kali Mandir, Ward No-7 of SMC. Under Siliguri Police Station, stating that on today dated-20/03/2026 around 9:00 Pm at night when I was passed from the Vivekananda Road, Near Kali Mandir after shopping then I saw that the all 3 persons are beating badly a person and snatched his money and the victim person came and stay behind me to save him and saw this I save him and try to stopped them the they all 3 persons are grab my collar and started slapped me as well as they all take a iron rod and hit over my head resulting blood started flow from my head and I have a deep cut on my head by the hit of iron rod one of the person Md Nasim hit me by a sharp blade upon my body and various cut has been done by the sharp blade when I started shouting loudly then they all took my gold chain from my neck and took my new cloths which was purchased by me for my family for festival (Eid) and ran away from the incident place the local people took me into the Siliguri District Hospital for treatment where doctor started treatment and several stiches done by the doctor over my head, banded my head and advised me for CT Scan because I have grievous injury by the hit on my head as well as in this incident I have grievous injury upon my body ( left side Solder) cut on my back and cut on my right hand.

So I am requesting before you to kindly accept my complaint as F.I.R and take strict action against all the persons who committed this offences.
