I, smt. Sabnam Begam wife of Md. Juber, resident of 7 No Ward Swami Nagar Colony, P.S. Siliguri, Dist- Darjeeling beg to inform you that some person's of our area namely Md. Bittu and Md. Azad are selling Brown Sugar everyday in front of our house. We have protested many times against their such activities. But last night at about 9:00 to 9:30 p.m. when they have again started such activity, that time, I along with my husband and son along with my other family members protested strongly against their activity, then they suddenly attacked upon us with 10 to 12 unknown persons with insist of their parents namely Md. Pinku (father) and Alpana (mother) and Md. Saddam with deadly weapons & lathi. They also threw stone from railway track. In this incident we all became little bit injured but my son namely Md. Aftaf sustain injury in the head and I also became the subject matter of outrage modesty and they turned down my wearing apparels and try to touch on my private parts.

Presently we are in fear of our life and property. All the miscreants are residence of Koila Dipo, Ward No. 7 SMC, P.S. Siliguri, District- Darjeeling.

Therefore, my humble submission to investigate the matter and take proper legal action against, the culprits.
